

RESOLUTION NO. 2015-234

A RESOLUTION AUTHORIZING THE ORMOC CITY MAYOR, HONORABLE EDWARD C. CODILLA, FOR AND ON BEHALF OF LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, MR. NESTOR B. RAMOS, FOR THE FULL IMPLEMENTATION OF THE EMERGENCY SHELTER ASSISTANCE (ESA) IN THE FORM OF CASH ASSISTANCE TO THE 28,984 FAMILIES WHOSE HOUSES WERE TOTALLY DAMAGED BY SUPER TYPHOON YOLANDA

WHEREAS, this 13th Sangguniang Panlungsod ng Ormoc was in receipt of two Indorsements dated October 19, 2015 and November 10, 2015 from the Honorable Ormoc City Mayor Edward C. Codilla recommending for the passage of a resolution authorizing him to enter into and sign a Memorandum of Agreement (MOA) for and on behalf of the LGU Ormoc with the Department of Social Welfare and Development (DSWD) Field Office VIII, represented by its Regional Director, Mr. Nestor B. Ramos, for the implementation of the Emergency Shelter Assistance (ESA) Project on the 28,984 families in the City whose houses were totally damaged by Super Typhoon Yolanda;

WHEREAS, to recall thru SP Resolution No. 2015-074 dated April 23, 2015 entitled: "A RESOLUTION AUTHORIZING THE ORMOC CITY MAYOR, HONORABLE EDWARD C. CODILLA, REPRESENTING THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, MR. NESTOR B. RAMOS, FOR THE IMPLEMENTATION OF THE EMERGENCY SHELTER ASSISTANCE (ESA), THEREBY AMENDING SANGGUNIANG PANLUNGSOD (SP) RESOLUTION NO. 2015-064 DATED APRIL 7, 2015" passed on April 23, 2015, this Sanggunian

had granted authority to the Ormoc City Mayor Honorable Edward C. Codilla to enter into and sign a previous MOA for the implementation of the ESA Project in the City by providing financial assistance to a total of 52,352 families whose houses were partially and totally damaged by Super Typhoon Yolanda;

WHEREAS, unfortunately due to funding gaps on the part of the DSWD, the rate of cash assistance to the family beneficiaries whose houses were totally damaged by Super Typhoon Yolanda was not distributed in full, thus leaving behind a balance of PHP 14,286.75 for each family beneficiary;

WHEREAS, the aforementioned Indorsements from the Honorable City Mayor seeks to settle the said balance for each of the family beneficiary in accordance with Memorandum Circular (MC) No. 24 series of 2014, the Guideline for the Full Implementation of the Emergency Shelter Assistance (ESA) Project for Families with Partially and Totally Damaged Houses Due to Typhoon "Yolanda");

WHEREAS, after careful and thorough perusal of the two subject MOAs attached to the Indorsements, this Sanggunian finds that the first subject MOA that seeks to release the financial assistance thru cash distribution to the family beneficiaries is found to be one in accordance with the clear intents of Memorandum Circular (MC) No. 24 series of 2014 (Guidelines for the Implementation of the Emergency Shelter Assistance [ESA] Project for Families with Partially and Totally Damaged Houses Due to Typhoon "Yolanda"), in contrast to the second subject MOA which release modality is in the form partial cash and roofing materials, which certainly is not in full compliance with the pertinent provisions of MC No. 24 series of 2014 as the modality of cash voucher system mentioned thereon is one whereby the LGU contracts out suppliers of housing materials within the locality, and the family beneficiaries themselves who purchase the housing materials, (a photocopy of the approved MOA is hereto attached and made an integral part hereof);

WHEREAS, this Sanggunian additionally finds that the first MOA is not contrary to public policy nor to existing contract, and is certainly in full promotion of the welfare, benefit and best interests of the recipient family beneficiaries of the ESA Project in Ormoc City and therefore, most deserving of its full and prompt favorable consideration, along with the conveyance of a message of extreme gratitude to the National Government for such noble and lofty program for the Ormocanons;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on joint motion of the Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, and the Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by the Honorable SP Members Rolando M. Villasencio, Tomas R. Serafica, Mario M. Rodriguez, Ruben R. Capahi, Antonio M. Codilla, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
