

RESOLUTION NO. 2015-237

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO IMPLEMENT THE PROJECT: WATER SUPPLY (LEVEL II) FOR VARIOUS BARANGAYS - CONSTRUCTION OF TWO (2) UNITS SPRING BOX, ONE (1) UNIT CONCRETE COLLECTING TANK AND PIPELINE INSTALLATION AT BARANGAY MABINI, THIS CITY, AS PER APPROVED CY 2015 ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY OF ORMOC WITH A TOTAL PROJECT COST OF FIVE MILLION PESOS ONLY (P5,000,000.00), TO BE FUNDED FROM THE 20% DEVELOPMENT FUND OF CY 2015.

WHEREAS, this august Body was in receipt of an urgent Indorsement from the Office of the City Mayor dated November 10, 2015 in relation to the preceding Indorsement from the City Planning and Development Office (CPDO) Coordinator, Engr. Raoul E. Cam, with regards to the letter request from Joseph Benedict C. Obejas, Acting Head of Office ORWASA, for the passage of a resolution authorizing the Honorable City Mayor to implement the project Water Supply (Level II) for various Barangays - Construction of two (2) Spring Box, one (1) unit Concrete Collecting Tank and Pipeline Installation at Barangay Mabini, this city, as per approved CY 2015 AIP;

WHEREAS, it can be recalled that this august Body has passed and approved SP Resolution No. 2014-188, entitled: A RESOLUTION APPROVING THE CY 2015 ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY OF ORMOC IN THE AMOUNT OF SEVEN BILLION EIGHT HUNDRED NINETY ONE MILLION ONE HUNDRED FORTY SEVEN THOUSAND EIGHTEEN PESOS (P7,891,147,018.00) AS CONTAINED IN CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO.2. SERIES OF 2014;

WHEREAS, the aforesated project for implementation is among the PPA's included in the CY 2015 AIP hence, the Indorsement of CPDO on the request of ORWASA Acting Head for this Sanggunian to grant authority to the Honorable City Mayor Edward C. Codilla to implement the same chargeable against the 20% Development Fund of CY 2015;

WHEREAS, this sanggunian has considered the request as reasonable and the effective implementation of the above named project is indeed beneficial as the subject water supply system construction will eventually provide the barangay constituents of Mabini as well as the neighboring Barangays an easy access of enough supply of potable water for their domestic needs which is safe from disease causing germs and thus, absolutely deserves this august Body's support and affirmative action;
