CORRO, VISAYAS STATE UNIVERSITY REPRESENTED BY ITS PRESIDENT, EDGARDO E. WHEREAS, this Sanggunian was in receipt of an Indorsement from the Office of the City Mayor dated December 2, 2015 requesting for the amendment of Resolution No. 2015-200 which was passed by this Sanggunian on October 15, 2015;
