RESOLUTION NO. 2015-247

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), REPRESENTED BY ITS REGIONAL DIRECTOR, PEDRO A. NOVAL JR., COVERING THE RECONSTRUCTION ASSISTANCE FOR YOLANDA (RAY) - DILG FUND AS GRANT FOR THE REPAIR/REHABILITATION/RESTORATION OF PARTIALLY/TOTALLY DAMAGED INFRASTRUCTURES OF LGU-ORMOC.

WHEREAS, this august Body was in receipt of an urgent Indorsement from the Office of the City Mayor dated December 9, 2015 requesting for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to enter into and sign the MOA by and between the DILG and LGU-Ormoc, for the Recovery Assistance for Yolanda - DILG Fund (RAY-DILG FUND) BATCH 3, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the MOA is intended only for the implementation of the DILG sub-projects which aims to recover and restore local government operations and accelerate socio-economic activities in typhoon-Yolanda affected areas;

WHEREAS, Ormoc City, being one of the eligible LGUs that were most affected by Typhoon Yolanda, has been identified as a recipient of the RAY-DILG Fund that will be utilized for the implementation of the package of sub-projects earlier submitted by LGU-Ormoc to DILG for possible funding as enumerated in the MOA;

WHEREAS, the DILG formulated the Reconstruction Assistance for Yolanda (RAY) – affected Areas – DILG Fund with an amount equivalent to FIFTY TWO MILLION NINE HUNDRED EIGHTY NINE THOUSAND SIX HUNDRED FORTY SEVEN PESOS & 48/100 (Php 52,989,647.48) as grant to LGU-Ormoc for the restoration and rebuilding of Yolanda damaged infrastructures in support of the Government's Reconstruction efforts and endeavors with due considerations on Build Back Better (BBB) to make them more disaster-resilient public infrastructures;

WHEREAS, the MOA encapsulate the terms and conditions of the agreement of the parties thereto, including their specific roles and obligations, towards the successful implementation of the sub-projects to be funded by the RAY-DILG Fund Batch 3 in Ormoc City, and this Sanggunian, upon thorough review of the MOA, finds that the same is indeed beneficial and will contribute much to the city's recovery and development, therefore, is most deserving of its prompt favorable consideration;

WHEREFORE, on joint motion of the Honorable SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation and Honorable SP Member Benjamin S. Pongos, Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C.
