WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated December 17, 2015 requesting for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to sign the MOAs by and between the DA-RFO 8, covering the four (4) priority poverty reduction projects as enumerated above, and LGU-Ormoc, a photocopy of the final MOAs are hereto attached and made an integral part hereof;

WHEREAS, the MOA refers to the implementation by LGU-Ormoc of the priority poverty reduction projects with DA allocation under RA 10633 also known as the General Appropriations Act of 2014 which provides fund for the BuB program;

WHEREAS, the Human Development and Poverty Reduction Cluster (HDPRC), the Good Governance and Anti-Corruption Cluster (GGAC), and the Economic Development Cluster (EDC) was organized under Executive Order No. 43, S. 2014, to implement BuB to ensure the inclusion of the funding requirements for the development needs of focus cities and municipalities in the budget proposals of participating agencies, in pursuit of the Millennium Development Goal of inclusive growth and poverty reduction;

WHEREAS, the BuB Program will make the planning and budgeting processes of both local and national governments more participatory through the genuine involvement of grassroots organizations and communities, strengthening the convergence of the delivery of national services in the community;

WHEREAS, as provided for in the agreements, the DA-RFO8 will transfer the funds to LGU-Crmoc by tranches in accordance with government accounting and auditing rules and regulations for the identified BuB proposed priority poverty reduction projects to be implemented, which was earlier prepared and submitted by the LGU in collaboration with the Local Poverty Reduction Action Team (LPRAT);

WHEREAS, the parties thereto have agreed to perform committedly their therein described obligations and responsibilities towards the achievement and successful implementation of the projects covered by the MOA, and this Sanggunian finds, after close and thorough review of the same, that it is extremely beneficial to the farmers in the matter that it will greatly help improve the farming communities by increasing their productivity and profitability, and so therefore, is most worthy of this august Body's prompt favorable consideration and support;
