A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE ORMOC CITY MAYOR EDWARD C CODILLA TO ENTER INTO AND SIGN A SERVICE CONTRACT, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), AS OWNER, WITH THE INTERNATIONAL AND EQUIPMENT, INCORPORATED, ELEVATOR REPRESENTED BY ITS SENIOR MANAGER, SERVICE DEPARTMENT, ELEVATOR & ESCALATOR DIVISION, MR. ORLANDO A. SENALES, AS CONTRACTOR, FOR THE MAINTENANCE OF THE MITSUBISHI **ELEVATOR** INSTALLED AT THE ORMOC CITY HALL.

WHEREAS, this august Body was in receipt of an Indorsement dated January 7, 2016 from the Office of the City Mayor recommending for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to sign the Mitsubishi Elevator Maintenance and Service Contract for and on behalf of LGU-Ormoc with the International Elevator and Equipment Inc., a photocopy of the final Service Contract is hereto attached and made an integral part hereof;

WHEREAS, the Service Contract involves the maintenance of the Mitsubishi Elevator installed at the Ormoc City Hall to be undertaken by the International Elevator & Equipment, Inc. which maintenance services covers the examination of the elevator, cleaning and adjustment of all motors, controls and safety devices, greasing and oiling of all bearings of all equipment and accessories, to be done once a month by the qualified servicemen of said contractor;

WHEREAS, the proposed Service Contract will be for a period of one (1) year, thenceforth said agreement is mutually considered automatically renewed every year, unless a written notice of termination or cancellation is served by either party on the other;

WHEREAS, the CONTRACTOR during the conduct of its maintenance services, agrees to provide at its own expense all necessary grease and lubricants, except gear oil and hydraulic oil, cleaning materials and replacement parts listed in the contract;

WHEREAS, LGU-Ormoc as the Owner agrees to pay the amount of FOUR THOUSAND ONE HUNDRED PHILIPPINE PESOS & 00/100 (PHP4,100.00) as monthly service fee for the services rendered by the CONTRACTOR as stated in the contract;

WHEREAS, the subject Service Contract has passed through the Office of the City Legal Officer, Atty. Ivan Verallo, who, upon thorough review thereof, issued a recommendation calling for the urgent passage of the appropriate Sanggunian resolution granting authority to the Honorable City Mayor to sign the same

WHEREAS, this Sanggunian finds the provisions of the Contract to be in order and beneficial as it is aimed at undertaking the proper and necessary maintenance of the existing elevator unit, which in turn, will ensure its safe use not only of the LGU employees and officials but the general public as well, who happens to be the end –users of the subject Elevator hence, deserving of prompt favorable action;
