A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE
CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND
SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON
BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC
(LGU-ORMOC) WITH THE DEPARTMENT OF AGRICULTURE -
REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8), REPRESENTED
BY ITS REGIONAL EXECUTIVE DIRECTOR, LEO P. CAÑEDA,
CESO III, COVERING THE TRANSFER OF FUNDS
AMOUNTING TO THREE MILLION SEVEN HUNDRED EIGHT
THOUSAND FIVE HUNDRED TWENTY FOUR PESOS AND
61/100 (PHP 3,708,524.61) AS GRANT FOR THE CITY OF
ORMOC FOR THE IMPLEMENTATION OF YOLANDA
REHABILITATION AND RECOVERY PROGRAM (YRRP) UNDER
THE 2015 REHABILITATION ASSISTANCE ON YOLANDA
(RAY).

WHEREAS, this august Body was in receipt of an Indorsement dated January 19, 2016 from the Office of the City Mayor, in connection with the preceding Indorsement from the City Agriculturist, Joseph C. Cortes, recommending for the passage of a resolution authorizing the Hon. City Mayor to enter into and sign the MOA for and on behalf of the Local Government Unit of Ormoc (LGU-Ormoc) with the Department of Agriculture - Regional Field Office No. 8 (DA-RFO 8), for the implementation of Yolanda Rehabilitation and Recovery Program (YRRP) under the 2015 Rehabilitation Assistance on Yolanda (RAY) involving the transfer of funds as grant for the City of Ormoc in relation to the aforesaid program, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, DA-RFO 8 as the implementing arm in Region 8 of the Department of Agriculture, has been tasked to implement its YRRP project which aim is to assist typhoon ravaged LGUs and communities to recover their agriculture and agriculture-related economic activities and enable farmers to start a new lease in life;

WHEREAS, in restoring the agriculture sector in Region 8, the DA-RFO 8 is implementing a "build back better" framework which is a comprehensive intervention that includes assistance in terms of production inputs, genetic materials, small infrastructure and machineries, production support facilities, and field supplies in partnership with the LGU;

WHEREAS, as provided for in the MOA, the DA-RFO 8 shall allocate and transfer the amount of THREE MILLION SEVEN HUNDRED EIGHT THOUSAND FIVE HUNDRED TWENTY FOUR PESOS AND 61/100 (PHP 3,708,524.61) as cash grant to LGU-Ormoc for the procurement of the interventions in line with implementation of YRRP under the 2015 RAY to be released in two (2) tranches as indicated in the List of Interventions and Schedule of Fund Releases hereto attached and considered part and parcel of this resolution;

WHEREAS, both LGU-Ormoc and DA-RFO8 share the vision of empowering the farmers and farmer organizations by providing them livelihood opportunities and support services to boost their recovery efforts;

WHEREAS, the subject MOA has passed through the Office of the City Legal Officer, Atty. Ivan Verallo, with the findings in an indorsement dated January 18, 2016 by said office that there is no legal impediment to implement the same and therefore recommending for the passage of a resolution authorizing the City Mayor to sign the MOA;

WHEREAS, the parties are mutually committed in collaborating with each other for the successful implementation of YRRP under the 2015 RAY, subject to the specific obligations and responsibilities of the involved parties towards the achievement of the lofty ends of the interventions to be procured as covered by the MOA and this Sanggunian finds, after close and thorough review of the same, that the MOA is extremely beneficial to the City and so therefore, most deserving of its utmost support and favorable consideration;

WHEREFORE, on motion of the Honorable SP Member John Eulalio Nepomuceno O. Aparis II, Member, Committee on Agriculture & Fisheries, severally seconded by the Honorable SP Members Mario M. Rodriguez, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga and Mariano Y. Corro; be it


ADOPTED, January 28, 2016.
