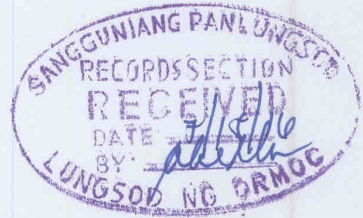

RESOLUTIO NO. 2016-011

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE  
ORMOC CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO  
AND SIGN A MEMORANDUM OF AGREEMENT (MOA), FOR  
AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF  
ORMOC (LGU-ORMOC), FOR THE ENGAGEMENT OF THE  
PROFESSIONAL SERVICES OF A LOCAL ECONOMIC  
DEVELOPMENT (LED) CONSULTANT.

WHEREAS, this august Body was in receipt of an urgent Indorsement dated July 07, 2016 from the Office of the Honorable City Mayor Richard I. Gomez pertaining to the Memorandum of Agreement (MOA) to be entered into by LGU-Ormoc with a Local Economic Development (LED) Consultant, a photocopy of the final MOA of which is hereto attached and made an integral part hereof;

WHEREAS, LGU-Ormoc will engage the professional services of a LED Consultant which is aimed at enhancing local governance relative to the City Mayor's exercise of his power and performance of functions and duties specifically in the general supervision and control over all programs, project, services and activities of the City;

WHEREAS, the aforementioned Consultant will: provide quality advice to the City Mayor on corporate matters as well as in assessing the emerging governance issues affecting the LGU; be responsible for the development of Local Economic Development (LED) strategic directions; and likewise, guide the City Government and its officials in achieving its LED goals;

WHEREAS, the MOA stipulates that the Consultant to be engaged by LGU-Ormoc shall possess the desired qualifications needed to carry out the services, including manifestation of his/her willingness to assist LGU-Ormoc to attain the objectives for which the Consultant shall be tasked to attain;

WHEREAS, the City Government of Ormoc does not presently have an employee who is capable of rendering the services as expected of the Consultant as declared by Ms. Adelaida H. Biacolo, City Human Resources Management Head;

WHEREAS, Acting City Legal Officer, Ormoc City Pros. Marcelo C. Oñate had declared that for as long as the requirements are met in the procurement of said Consultant, there is no legal obstacle to hire such Consultant;

WHEREAS, the terms and conditions set forth in the MOA are unequivocal, fair, reasonable and satisfactory to both parties concerned;

WHEREAS, the proposed hiring of the Local Economic Development (LED) Consultant is in accordance with the provisions of Section 24 of the Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon close and thorough review, this Sanggunian finds that the MOA is not contrary to law, existing contract and public morals, and that its goal to engage the much needed services of a Local Economic Development (LED) Consultant is indeed beneficial to the City specifically in carrying out the thrusts of the present administration of providing efficient, effective and economical governance, and promoting the general welfare of the City and so therefore, rendering the same most deserving of this august Body's prompt support and favorable action;

WHEREFORE, on motion of the Honorable SP Member Mario M. Rodriguez, Member, Committee on Laws and Ordinances, severally seconded by the Honorable SP Members Tomas R. Serafica, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE HONORABLE ORMOC CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA), FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), FOR THE ENGAGEMENT OF THE PROFESSIONAL SERVICES OF A LOCAL ECONOMIC DEVELOPMENT (LED) CONSULTANT;


