RESOLUTION NO. 2016-017

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE REVISED MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), REPRESENTED BY ITS REGIONAL DIRECTOR, PEDRO A. NOVAL, JR., COVERING THE RECONSTRUCTION ASSISTANCE FOR YOLANDA (RAY)- DILG FUND (BATCH 3) AS GRANT FOR THE REPAIR/REHABILITATION/RESTORATION OF PARTIALLY/TOTALLY DAMAGED INFRASTRUCTURES OF LGU-ORMOC THEREBY AMENDING SP RES. NO. 2015-247 DATED DECEMBER 21, 2015.

WHEREAS, an indorsement dated February 3, 2016 from the Office of the City Mayor was received by this august Body urgently requesting for the passage of an amendatory resolution with regards to Resolution No. 2015-247 which was earlier passed and adopted by this Sanggunian entitled: RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), REPRESENTED BY ITS REGIONAL DIRECTOR, PEDRO A. NOVAL, JR., COVERING THE RECONSTRUCTION ASSISTANCE YOLANDA (RAY)-DILG FUND AS GRANT OF REPAIR/REHABILITATION/RESTORATION PARTIALLY/TOTALLY DAMAGED INFRASTRUCTURES OF LGU-ORMOC ";

WHEREAS, to recall, the MOA which was the subject of said Resolution No. 2015-247 object of the requested amendment, involved a total amount of P52, 989,647.48 of RAY-DILG Fund (Batch 3)to be extended to LGU-Ormoc as grant for the restoration and rebuilding of Yolanda damaged infrastructures;

WHEREAS, through a communication dated February 2, 2016 from the Office of the DILG City Director, it was laid down that there is a recent modification in the implementation of RAY Projects Batch 3 as embodied in the MOA which was earlier approved through SP Resolution No. 2015-247 duly adopted by this Sanggunian on December 21, 2015, to the effect that the implementation of the Flood Control and Drainage sub projects being one of the components for funding under the said previous approved MOA, have been transferred to the Department of Public Works and Highways (DPWH) thus, resulting to a significant change in the amount to be granted to LGU-Ormoc;

WHEREAS, as provided for in the previous MOA as embodied in SP Res. No. 2015-247, the total cost of projects to be funded by DILG under RAY Batch 3 is equivalent to P52,989,647.48, however, considering the aforestated changes in the implementation thereof the amount to be granted to LGU-Ormoc has decreased and now only totals to P9,989,647.48 representing the cost of Barangay Facilities and Water Facilities sub-projects that will be implemented by LGU-Ormoc , THEREBY the need for the parties to undertake a new agreement (Revised MOA) covering the matter, hence this request;

WHEREAS, upon perusal by the City Legal Office of the revised MOA, it was found out that there is indeed a need to carry out the requested amendment to SP Resolution No. 2015-247 specifically indicating therein that the amount to be granted to LGU-Ormoc shall only be for the Barangay and Water Facilities subprojects which is maintained at P9,989,647.48;

WHEREAS, this Sanggunian upon close examination of the provisions of the revised MOA, finds the same to be in order, hence the amendment request to SP Resolution No. 2015 247 is deserving of prompt favorable action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of the Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances severally seconded by the Honorable SP Members Rolando M. Villasencio, Tomas R. Serafica, Ruben R. Capahi, Antonio M. Codilla, Vincent L. Rama, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
