RESOLUTION 2016-018

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE PHILIPPINE COUNCIL FOR AGRICULTURE AND FISHERIES (PCAF), REPRESENTED BY ITS EXECUTIVE DIRECTOR, ARIEL T. CAYANAN, FOR THE DOWNLOADING OF THE AMOUNT OF FORTY EIGHT THOUSAND PESOS (P48,000.00) AS GRANT INTENDED FOR THE CY 2016 OPERATIONAL FUNDS OF THE INDEPENDENT COMPONENT CITY AGRICULTURE AND FISHERY COUNCIL (ICCAFC) OF ORMOC CITY.

WHEREAS, this august Body was in receipt of an Indorsement dated February 2, 2016 from the Office of the City Mayor, with reference to the preceding Indorsement from the City Agriculturist, Joseph C. Cortes, recommending for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign the MOA for and on behalf of the Local Government Unit of Ormoc (LGU-Ormoc) with the Philippine Council for Agriculture and Fisheries (PCAF), for the downloading of the CY 2016 Operational Funds for the ICCAFC in Ormoc City in the amount of Forty Eight Thousand Pesos (P48,000.00), a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, PCAF as an agency of the Department of Agriculture, is mandated among others, as consultative arm to serve as forum where government and private sector discuss issues and come up with policy recommendations concerning agriculture and fisheries;

WHEREAS, the CY 2016 PCAF budget provides fund for local Agricultural Fishery Council (AFC) operations to be utilized and released as grants and subsidies through the DA-RFOs and authorized conduits;

WHEREAS, as provided for in the MOA, the PCAF shall allocate and release the amount of FORTY EIGHT THOUSAND PESOS (P48,000.00) to LGU-Ormoc as CY 2016 operational funds for the ICCAFC specifically for the maintenance and operating expenses (MOOE) during the conduct of consultative meetings;

WHEREAS, the parties thereto have agreed to perform committedly their therein described covenants and stipulations towards the successful downloading of the said funds as covered by the MOA, and this Sanggunian finds, after close and thorough review of the same, that it is beneficial and a great help to the ICCAFC in Ormoc City when conducting consultative meetings as an avenue to discuss issues and concerns involving agriculture and fisheries, and so therefore, is most worthy of this august Body's prompt favorable consideration and support;

WHEREFORE, on joint motion of the Honorable SP Member Tomas R. Serafica, Chairman, Committee on Agriculture & Fisheries and the Honorable SP Member Mariano Y. Corro, Vice-Chairman, Committee on Laws and Ordinances, severally seconded by the Honorable SP Members Rolando M. Villasencio, Ruben R. Capahi, Antonio M. Codilla, Vincent L. Rama, Eusebio Gerardo S. Pensergera and John Eulalio Nepomuceno O. Aparis II; be it


ADOPTED, February 11, 2016.
