RESOLUTION NO. 2016-018

*A RESOLUTION AMENDING SECTION 2, RULE VII OF THE
INTERNAL RULES OF PROCEDURE OF THE 14TH
SANGGUNIANG PANLUNGSOD NG ORMOC.*

WHEREAS, this 14th Sangguniang Panlungsod ng Ormoc passed and approved during its Inaugural Session held on June 30, 2016 Resolution No. 2016-001, entitled: "A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 14TH SANGGUNIANG PANLUNGSOD NG ORMOC" in compliance to the provisions of the Local Government Code of 1991;

WHEREAS, in view of the fervent desire of the Sangguniang Panlungsod Members to optimize their capabilities and be able to render effective public service and governance, it was agreed upon by the Body to effect some amendments to the said adopted Rules of Procedure;

WHEREAS, upon incorporation of the proposed amendment to the Internal Rules of Procedure of this Sanggunian, Section 2, Rule VII thereof shall now read as follows:

RULE VII- REGULAR COMMITTEES

Section 2. - Composition. Every regular committee to be created shall be composed of not more than Five (5) members including the Chairman and Vice-Chairman except the Committee on Finance and Appropriation; Committee on Good Government; Committee on Oversight and Legislative Tracking ; and Committee on Ways and Means.


