A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST) REGION VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, ENGR. EDGARDO M. ESPERANCILLA, FOR THE IMPLEMENTATION OF THE PROJECT ENTITLED: "DEPLOYMENT OF EARLY WARNING SYSTEM (DEWS) IN DISASTER - PRONE AREAS" OF ORMOC CITY.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated February 2, 2016 covering the MOA to be entered into by LGU-Ormoc with the DOST Region VIII, for the implementation of the project entitled: "Deployment of Early Warning System (DEWS) in Disaster – Prone Areas", a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, DOST-VIII has been assisting the LGUs and other government offices through various science-based programs and projects which have positive impacts to regional development;

WHEREAS, in furtherance of its thrust, DOST-VIII collaborated with the Advanced Science and Technology Institute (ASTI) and the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) in the implementation of the project "Deployment of Early Warning System (DEWS) in Disaster – Prone Areas";

WHEREAS, the component of the said project involves the provision and installation of one (1) unit Automated Rain Gauge (ARG) at the agreed site in Lake Danao View Deck area, Brgy. Danao, Ormoc City and one (1) unit Water Level Monitoring System (WLMS) in Brgy. Liloan, Ormoc City by the DOST – VIII subject to the conditions set forth in the MOA;

WHEREAS, as laid down in the Indorsement dated January 20, 2016, from Ciriaco E. Tolibao, CDRRMO Designate, the DOST – DEWS Team, together with the Ormoc City DRRMO personnel has surveyed and selected the sites deemed suitable for the installation of said monitoring equipment with due consideration to the availability of SMS signal, easy maintenance access, safety of the equipment and site appropriateness for monitoring;

WHERWAS, LGU-Ormoc is committed in hosting the installation and operation of the said hybrid weather monitoring equipment to obtain real-time weather situation prevailing in the city;

WHEREAS this Sanggunian finds, after close and thorough review of the MOA, that it is indeed not contrary to law, public policy, and public morals and further, that it is in fact extremely beneficial to the city and its constituents particularly to those who are in Disaster-prone areas, the project being an integral part of city's disaster preparedness program, and therefore, is most deserving of the august body's full support and prompt favorable consideration;
