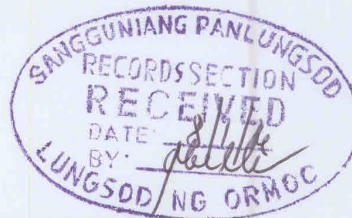

RESOLUTION NO. 2016-020

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE PHILIPPINE CHAMBER OF COMMERCE AND INDUSTRY (PCCI), REPRESENTED BY ITS VICE PRESIDENT, JOSE T. NG AND ORMOC CITY CHAMBER OF COMMERCE AND INDUSTRY INC. (OCCCI), REPRESENTED BY ITS PRESIDENT, JUDE P. ABENOJA FOR THE PARTNERSHIP IN HOSTING THE VISAYAS AREA BUSINESS CONFERENCE (VABC) ON SEPTEMBER 13, 14, 15, AND 16, 2016 TO BE HELD IN ORMOC CITY.

WHEREAS, a communication was received by this Sanggunian dated July 19, 2016 from the Office of the City Mayor pertaining to the attached letter from the Ormoc City Chamber of Commerce and Industry Inc. (OCCCI) for a resolution giving the Honorable City Mayor Richard I. Gomez the authority to sign the Memorandum of Understanding (MOU) for the partnership in hosting the Visayas Area Business Conference (VABC) on September 13, 14, 15, and 16, 2016, a photocopy of the final MOU is hereto attached and made an integral part hereof;

WHEREAS, the MOU covers the organization, preparation and conduct of VABC in Ormoc City on the aforementioned dates including trade exhibits and ancillary activities;

WHEREAS, PCCI being an institution of private business sector which is recognized as the "Voice of the Philippine Business" was established to contribute to the cause of countrywide socio-economic development;

WHEREAS, in the pursuit of its thrust, PCCI holds Area Business Conferences (ABCs) in its five (5) regions namely, North Luzon, NCR, South Luzon, Visayas and Mindanao where regional business concerns are discussed and relevant area policy recommendations, strategies and plans of actions are formulated;

WHEREAS, OCCCI is a non-profit organization of local businessmen in Ormoc City established to promote trade and investments in the area towards the attainment of sustainable and equitable development;

WHEREAS, Ormoc City has been selected as the venue for the VABC with the OCCCI as the host Chamber. Cognizant of the positive impact of the Visayas ABC to the local economy, LGU-Ormoc fully supports the conduct of this event in the City on the aforementioned dates;

WHEREAS, the parties wish to undertake a partnership and extend their cooperation and support for the success of the said event, subject to their respective specific roles and responsibilities, as stipulated in the MOU, and this Sanggunian, after close and thorough review of the same, finds that it is indeed beneficial to the City as it directly impacts the promotion of trade and investments as well as in strengthening relevant concerns and issues affecting the business sector; and this Body further concludes that the MOU is not contrary to law, agreement, public policy and morals, thus most deserving of this august body's prompt and utmost support and favorable consideration;


RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Understanding (MOU) be furnished to this Sanggunian for its information and files;
