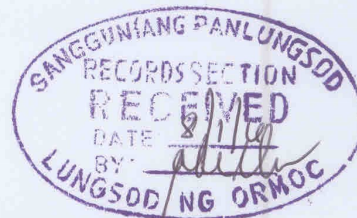

RESOLUTION NO. 2016-022

A RESOLUTION APPROVING THE APPLICATION FOR
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT
OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF
ORDINANCE NO. 009 DATED OCTOBER 16, 2014 OF
ORMOC-KANANGA MILL DISTRICT DEVELOPMENT
COUNCIL FOUNDATION INC.

WHEREAS, this august Body received the application of Ormoc – Kananga Mill District Development Council Foundation Inc., a Civil Society Organization (CSO) requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, Ormoc – Kananga Mill District Development Council Foundation, Inc. is a non-profit, non-stock corporation organized to help sugar cane farmers in cultivating their farm with a view to promoting the development and enhancing the viability and global competitiveness of the sugar industry and improving the lot of everyone involved in said industry;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforesaid applications, finds that the same are in order, and the purposes of the sought accreditation are for the aforementioned organization to move forward its noble intentions to promote moral, social and economic development among its members through the establishment of a strong linkage with the LGU in order for the association to have a better access to future agricultural programs of the government that are beneficial to its members;

WHEREAS, further, this august Body deem the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the Honorable SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the Honorable SP Members Tomas R. Serafica, Mariand Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II, Nolito M. Quilang and Benjamin S. Pongos; be it


