RESOLUTION NO. 2016-029

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE  
CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND  
SIGN A CONTRACT OF SERVICE (RENEWAL) FOR AND ON  
BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC  
(LGU-ORMOC) WITH THE DEPARTMENT OF HEALTH (DOH),  
REPRESENTED BY ITS REGIONAL DIRECTOR, DR. MINERVA  
P. MOLON AND MS. SHARMAIN C. GALENZOGA (MIDWIFE)  
FOR THE CONTINUOUS IMPLEMENTATION OF THE DOH  
RURAL HEALTH MIDWIVES PLACEMENT PROGRAM  
(RHMPP).

WHEREAS, this august Body was in receipt of an Indorsement dated February 10, 2016 from the Office of the Honorable City Mayor Edward C. Codilla in connection with the Indorsement from Dr. Nelita D. Navales, City Health Officer II, recommending for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign the renewal Contract of Service for and on behalf of LGU-Ormoc with the DOH and Ms. Sharmain C. Galenzoga, a photocopy of the final Contract of Service of which is hereto attached and made an integral part hereof;

WHEREAS, the subject Contract of Service is for the continuous implementation of the DOH Rural Health Midwives Placement Program (RHMPP) furthermore, particularly covering the "Return Service" of Ms. Sharmain C. Galenzoga in Ormoc City in relation to her 2-year Midwifery Scholarship from the DOH-RHMPP which she agreed to serve and render service within a period of four (4) years upon completion of the said scholarship grant;

WHEREAS, it can be recalled that this Sanggunian had already acted Three (3) SP Resolutions regarding the Contract for the "Return Service" of Ms. Sharmaine C. Galenzoga, covering three cycles of her "Return Service" which duration of each cycle is good for Six (6) months only, the latest of which is SP Resolution No. 2015-202 dated October 15, 2015 which dealt with the preceding contract of Ms. Galenzoga for the period July 2015 to December 2015, renewable every six (6) months of service;

WHEREAS, in connection with the expiration of the previous Contract, and considering that the parties to the Contract of Service mutually agreed for the continuous implementation of said "Return Service" of Ms. Galenzoga in Ormoc City, there is a need to have this Renewal of Contract acted upon favorably for its outright execution in conformity with the terms and conditions set forth therein;

WHEREAS, upon close and thorough review of the current contract, this Sanggunian finds the provisions to be in order, the period being covered is also good for another Six (6) months effective January 2016 until June 2016, and further, this august Body deems that the same is indeed beneficial to the City of Ormoc as the continued engagement of the much-needed services of Ms. Galenzoga will augment the City Health Office workforce specifically in the delivery of midwives' health services, whose salary shall nonetheless be paid by the DOH;

WHEREFORE, on motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Antonio M. Codilla, Vincent L. Rama, Eusebio Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A CONTRACT OF SERVICE FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF HEALTH (DOH), REPRESENTED BY ITS REGIONAL DIRECTOR, DR. MINERVA P. MOLON AND MS. SHARMAINE C. GALENZOGA (MIDWIFE) FOR THE CONTINUOUS IMPLEMENTATION OF THE DOH RURAL HEALTH MIDWIVES PLACEMENT PROGRAM (RHMP);


ADOPTED, February 23, 2016.
