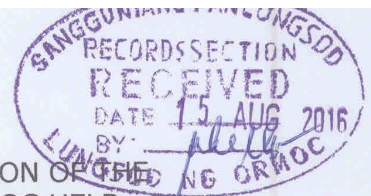

RESOLUTION NO. 2016-030

A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ TO DISPOSE OF THE NON-PERFORMING ASSETS (UNSERVICEABLE MOTOR VEHICLES, HEAVY EQUIPMENT, AND MOTORCYCLES), AND WASTE MATERIALS OF USED TIRES, INCLUDING TO PERFORM ALL NECESSARY ACTS FOR THE ACCOMPLISHMENT OF THE SAME, SUBJECT TO COMMISSION ON AUDIT (COA) AND OTHER RULES AND REGULATIONS.

WHEREAS, this Sanggunian was in receipt of an Indorsement dated August 5, 2016 from the Office of the City Mayor requesting for the passage of a resolution granting him authority to dispose the non-performing assets (unserviceable vehicles, heavy equipment and motorcycles), certified as urgent and which matter was previously submitted to the Disposal Committee for Appraisal by the previous administration;

WHEREAS, as provided for in Title VI of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991 (LGC), government property that have become unserviceable or no longer needed shall be sold, whenever applicable, at public auction, subject to applicable rules and regulations;

WHEREAS, the LGC also provides that when property of any local government unit has become unserviceable for any cause or is no longer needed, it shall, upon application of the officer accountable therefor, be inspected and appraised by the City Auditor, as the case may be, or his duly authorized representative or that of the Commission on Audit;

WHEREAS, Section 379 of the same points out that if such property is found valuable, the same shall be sold at public auction to the highest bidder under the supervision of the Committee on Awards and in the presence of the City Auditor or his duly authorized representative;

WHEREAS, further, pursuant to Section 79 of PD 1445, it is also mandated that, to wit "When government property has become unserviceable for any cause or no longer needed, it shall, upon application of the officer accountable therefore, be inspected by the head of the agency of his duly authorized representative;

WHEREAS, in a communication dated July 13, 2016, from Engr. Domardoni Cayanong, City General Services Officer addressed to Vincent Emnas, OIC-City Administrator, the former had endorsed to the latter the Inventory and Inspection Report of Unserviceable Property (unserviceable vehicles, heavy equipment and motorcycles) and Waste Material Report of Used Tires dated December 31, 2015, copies of which are hereto attached and made integral parts hereof;

WHEREAS, upon close and thorough review, this Sanggunian finds, that the requested authorization to the City Mayor will further facilitate the expeditious disposal of unserviceable property and aid the disposal committee to undertake the disposition of said properties, subject to COA and other rules and regulations, and that the same is most beneficial to the City as not only will it raise much-needed funds for the City Government but will also prevent its further deterioration and unsightliness, and clear the area where the same are being stored or stocked, therefore, meriting this august Body's full support and favorable action;

WHEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws & Ordinances, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II, Nolito M. Quilang, Gregorio G. Yrastorza, III, Eusebio Gerardo S. Penserga and Tomas R. Serafica; be it


