RESOLVITION NO. 2016-031

A RESCLUTION AMENDING SECTIONS 1 AND 8, RULE VIII OF THE WITER VAL RULES OF PROCEDURE OF THE 14TH SANGGWIANG PANLUNGSOD NG ORMOC.

WHEREAS, this august Body had passed and approved SP Resolution No. 2016-001 dated June 30, 2016, entitled: "A RESOLUTION ADOPTING THE INTERNAL RULES OF PROCEDURE OF THE 14TH SANGGUNIANG PANLUNGSOD NG ORMOC" in compliance with Section 50 of the Local Government Code of 1991 which provides that: "on the First Regular Session following the election of its members and within ninety (90) days thereafter, the Sanggunian concerned shall adopt and or update its existing rules of procedure";

WHEREAS, the aforesaid adopted Internal Rules of Procedure had fixed the regular session of this Sanggunian once a week to be held at the Sanggunian Session Hall every Thursday at exactly 2:00 o'clock in the afternoon and the presession caucus to be held immediately after said regular session;

WHEREAS, upon deliberation and consideration by the members of this august Body, it was agreed upon that the time of the Regular Session of the 14th Sanggunian be moved to 9:00 o'clock in the morning of every Thursday of the week instead of 2:00 o'clock schedule due to reasons of convenience and effectiveness and the pre-session caucus immediately after, hence, there is a necessity to amend Section 1 and 8, Rule VIII of the Internal Rules of Procedure of the 14th Sanggunian, such that they shall now read as follows:

"RULE VIII - REGULAR AND SPECIAL SESSIONS AND PRE - SESSION
CAUCUS

Section 1. The regular session of this Sanggunian shall be "once a week" to be held at the Sanggunian Session Hall every Thursday at exactly 9:00 o'clock in the morning.

Section 8. The pre-session caucus of this Sanggunian shall be held immediately after the holding of each regular session. However, additional pre-session caucus may also be held subject to the agreement of the members of this Sanggunian."

WHEREFORE, on motion of SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Internal Rules of Procedure, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, Nolito M. Quilang, Eusebio Gerardo S. Penserga and Tomas R. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a A RESOLUTION AMENDING SECTIONS 1 AND 8, RULE VIII OF THE INTERNAL RULES OF PROCEDURE OF THE 14TH SANGGUNIANG PANLUNGSOD NG ORMOC;
