A RESOLUTION AUTHORIZING THE HONORABLE CITY  
MAYOR EDWARD C. CODILLA, REPRESENTING THE  
ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN  
THE MEMORANDUM OF AGREEMENT (MOA) WITH THE  
DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT  
(DSWD) REGIONAL OFFICE NO. 8 FOR THE  
IMPLEMENTATION OF THE SOCIAL PENSION FOR  
INDIGENT SENIOR CITIZENS FOR CY 2016.

WHEREAS, this 13<sup>th</sup> Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement dated February 5, 2016 from the Honorable City Mayor Edward C. Codilla, pertaining to the request of Mansueta N. Teleron, OSCA Head, recommending for the passage of a Resolution authorizing the Honorable City Mayor to enter into and sign a Memorandum of Agreement (MOA) by and between the Department of Social Welfare and Development (DSWD) Regional Field Office No. 8 and the Local Government Unit of Ormoc for the implementation of the Social Pension for Indigent Senior Citizens CY 2016;

WHEREAS, having been mandated to provide social welfare and development programs, the DSWD continuously implements programs/projects and provides augmentation assistance to the Local Government Units (LGUs) that would help alleviate poverty and ensure welfare of the disadvantaged and vulnerable groups;

WHEREAS, the Social Pension for Indigent Senior Citizens is the realization of Republic Act No. 9994, otherwise known as the "Expanded Senior Citizens Act of 2010" which affords a monthly stipend amounting to Five Hundred Pesos (Php 500.00) to the qualified senior citizens in order to augment their daily subsistence and other medical needs as response of the government to the vulnerable sector, and which stipend will be distributed once in every quarter in the amount of One Thousand Five Hundred Pesos (Php 1,500.00) in total;

WHEREAS, the subject MOA is deemed considerably beneficial to the City's indigent senior citizens and is therefore worthy of this august Body's consideration and support;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on joint-motion of the Honorable SP Member Vincent L. Rama, Chairman of the Committee on Social Welfare, Senior Citizens, Women and Family and the Honorable SP Member Benjamin S. Pongos, Jr., Chairman of the Committee on Laws and Ordinances, severally seconded by the Honorable SP Members Rolando M. Villasencio, Tomas R. Serafica, Ruben R. Capahi, Antonio M. Codilla, Pedro Godiardo P. Ebcas, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE NO. 8 FOR THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS FOR CY 2016";

RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement be submitted to this Sanggunian for information and file;


