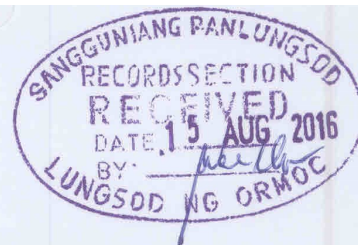

RESOLUTION NO. 2016-032

A RESOLUTION APPROVING THE APPLICATION FOR
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT
OF ORMOC OF ORMOC CITY CHAMBER OF COMMERCE
AND INDUSTRY INC. (ORCHAM), IN ACCORDANCE WITH
THE PROVISIONS OF ORDINANCE NO.009 DATED
OCTOBER 16, 2014.

WHEREAS, this august Body received the application of Ormoc City Chamber of Commerce and Industry Inc. (ORCHAM), a Civil Society Organization (CSO), requesting for re-accreditation with the Local Government Unit of Ormoc;

WHEREAS, ORCHAM is a non-stock and non-profit association of local businessmen in Ormoc City. Among its purposes is to serve as the voice of the local business and an independent forum for the development of a consensus of the business community on matters of local or national concern as well as fostering closer relations, understanding and cooperation with the agricultural, commercial and industrial sectors of the economy in the locality;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) - day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforesaid application, finds that the same is in order, and the purposes of the sought accreditation is for the aforementioned organization to move forward its noble intentions to promote moral, social and economic development among its members through the establishment of a strong linkage with the LGU for them to be able to perform an active role in helping shape the course of local or national events and make known its position on issues affecting local or national interest;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No, 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II, Nolito M. Quilang, Benjamin S. Pongos, Jr. and Tomas R. Serafica; be it




