## RESOLUTION NO. 2016-032

WHEREAS, this august Body received the application of Ormoc City Chamber of Commerce and Industry Inc. (ORCHAM), a Civil Society Organization (CSO), requesting for re-accreditation with the Local Government Unit of Ormoc;
