RESOLUTION 2016-033

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND STOW A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-QRMOC) WITH THE **PHILIPPINE** COCONUT AUTHORITY (PCA), REPRESENTED ITS BYOIC ALMINISTRATOR, GLENN B. SANTOS, FOR THE IMMEDIATE ESTABLISHMENT OF LOCAL COCONUT NURSERY FOR DRMOC CITY UNDER THE YOLANDA REHABILITATION AND RECOVERY PROGRAM (YRRP).

WHEREAS, this august Body was in receipt of an urgent Indorsement dated February 22, 2016 from the Office of the City Mayor, pertaining to the preceding Indorsement from the City Agriculturist, Joseph C. Cortes, recommending for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign the MOA for and on behalf of LGU-Ormoc with the PCA, represented by its OIC Administrator, Glenn B. Santos, for the immediate establishment of Local Coconut Nursery for Ormoc City under Yolanda Rehabilitation and Recovery Program (YRRP), a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, PCA is a government - owned and controlled corporation under the Office of the Presidential Assistant for Food Security and Agricultural Modernization in authority for the development of the coconut industry to its full potential in line with the new vision of a united, globally competitive industry;

WHEREAS, both LGU-Ormoc and PCA endeavors in working together to address the tremendous damage caused by Super Typhoon Yolanda to the coconut farms in Ormoc City through the implementation of immediate replanting of coconut seeds in the affected coconut plantation through YRRP;

WHEREAS, the YRRP covers the establishment of local nurseries in LGUs to ensure that seedlings to be planted come from known high-yield sources and free from plant pest and diseases;

WHEREAS, the subject MOA has passed through the Office of the City Legal Officer, Atty. Ivan Verallo, with the findings in an indorsement dated February 22, 2016 by said office that there is no legal impediment to implement the same and therefore recommending for the passage of a resolution authorizing the City Mayor to sign the MOA;

WHEREAS, the parties are mutually committed in collaborating for the successful establishment of Local Coconut Nursery under the YRRP, subject to the specific obligations and responsibilities covered by the MOA and this Sanggunian finds, after close and thorough review of the same, that the MOA is extremely beneficial to the farmer beneficiaries and to the City as well and so therefore, most deserving of its utmost support and favorable consideration;

WHEREFORE, on joint motion of the Honorable SP Member Tomas R. Serafica, Chairman, Committee on Agriculture & Fisheries and Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by the Honorable SP Members Antonio M. Codilla, Pedro Godiardo P. Ebcas, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it

CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE PHILIPPINE COCONUT AUTHORITY (PCA), REPRESENTED BY ITS OIC - ADMINISTRATOR, GLENN B.
