- WHEREAS, this august Body received the applications for accreditation with the Local Government Unit of Ormoc of the following Civil Society Organizations (CSOs), to wit:
 - 1. OCCIDENTAL LEYTE BAR ASSOCIATION INC. (OLBA)
 - 2. ORMOC FESTIVAL & CULTURAL FOUNDATION, INC.
 - 3. PARTNERS MULTI-PURPOSE COOPERATIVE (PMPC)

WHEREAS, OLBA, is an aggrupation of members of the bench and bar from the cities of Ormoc and Baybay and the Municipalities of Albuera, Bato, Hilongos, Hindang, Inopacan, Isabel, Kananga, Matag-ob, Matalom, Merida, Palompon, San Isidro, Tabango and Villaba which is formed to elevate the legal profession, improve the administration of justice, and enable the association to discharge its public responsibility more effectively being in the forefront in promoting and upholding the principles of justice and equity;

WHEREAS, Ormoc Festival & Cultural Foundation, Inc., is a non-stock and non-profit institution which primary purpose is to promote and enhance cultural awareness in Ormoc Society through activities and festivals that depict Ormoc's History and culture, in order to attract and enhance the city's tourism potential as the region's tourist destination;

WHEREAS, PMPC which is the umbrella organization of various farmers and community associations belonging to the Sixteen (16) Primary Partner barangays (PPB's) of Energy Development Corporation (EDC) is among the CSOs which were granted accreditation by the previous Sanggunian and is presently requesting for re-accreditation;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOS) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) - day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after thorough review of the aforesaid applications, finds that the same are in order, and the purposes of the sought accreditation are for the aforementioned organizations to move forward its noble intentions to promote moral, social and economic development among its members as well as to partner with LGU in its endeavors to further develop the local economy through the implementation of diverse programs and projects that will benefit all sectors of the community:
