## RESOLUTION NO. 2016-03

A RESOLUTION GRANTING AUTHORITY TO THE CITY TREASURER, MS. DELIA C. VILBAR AND THE OIC - CITY ADMINISTRATOR, MR. VINCENT L. EMNAS, TO OPEN A SPECIAL TRUST FUND ACCOUNT WITH LAND BANK OF THE PHILIPRINES (LEP) - ORMOC BRANCH, UNDER THE ACCOUNT NAME CLGU-ORMOC BOTTOM-UP BUDGETING TO SERVE AS THE CITY'S DEPOSITORY ACCOUNT FOR ALL BOTTOM-UP BUDGETING (BUB) FUNDS.

WHEREAS, this august Body was in receipt of an Indorsement dated August 4, 2016 from the City Mayor Richard I. Gomez, pertaining to the letter request from the City Treasurer, Ms. Delia C. Vilbar, requesting for authority to open a Trust Fund Account in one of LGU-Ormoc depository Banks, the Land Bank of the Philippines (LBP) – Ormoc Branch, with herself, in her capacity as City Treasurer, and the OIC City Administrator, Mr. Vincent L. Emnas as the authorized signatories, for LGU Ormoc Bottom-Up Budgeting (BuB) funds;

WHEREAS, such request of the City Treasurer was anchored on the previous request made by the City Agriculturist, Dr. Joseph C. Cortes, to cause the opening of a Special Trust Fund Account, to be referred to as CLGU-Ormoc Bottom-Up Budgeting since this is one of the requirements needed by the Department of Agriculture-Regional Field Unit 8 for the release of funds for various 2015 and 2016 BuB projects granted to LGU-Ormoc;

WHEREAS, upon verification from the Office of the City Accountant, it was gathered that as per records there is yet no Special Trust Fund Account bearing the name of CLGU-ORMOC Bottom-Up Budgeting that has been opened with any Government Bank in the City;

EMNAS, TO OPEN A SPECIAL TRUST FUND ACCOUNT WITH LAND BANK OF THE PHILIPPINES (LBP) - ORMOG BRANCH, UNDER THE ACCOUNT NAME CLGU-ORMOG BOTTOM-UP BUDGETING TO SERVE AS THE CITY'S DEPOSITORY ACCOUNT FOR ALL BOTTOM-UP BUDGETING (BUB) FUNDS;
