THIRTEEN (13) DELEGATIONS DURING THE RECENTLY
CONCLUDED 2016 EASTERN VISAYAS REGIONAL ATHLETIC
ASSOCIATION (EVRAA) HELD IN THE CITY AND
SUPPORTING THE HONORABLE CITY MAYOR IN GRANTING
INCENTIVES AND AWARDS FOR THEIR OUTSTANDING
PERFORMANCES, SUBJECT TO THE PERTINENT
ACCOUNTING AND AUDITING RULES AND REGULATIONS.

WHEREAS, it is the policy of the State to promote physical education, encourage and sustain the development of sports in the country to foster physical fitness, self-discipline, teamwork and excellence for the development of a healthy and alert citizenry;

WHEREAS, the Eastern Visayas Regional Athletic Association (EVRAA) is one of the programs by the Department of Education which is pursuant to the abovementioned policy;

WHEREAS, the City of Ormoc hosted the recently concluded EVRAA 2016 and participated as well in the said event;

WHEREAS, the Ormoc City delegates ranked third (3rd) among the thirteen delegations who participated in the various sporting events in the said week-long event;

WHEREAS, this August body is in receipt of an indorsement from the Office of the City Mayor requesting for the passage of a resolution to recognize and congratulate the achievements of the Ormoc City athletes and coaches for the pride and honor they brought to this city with their aforementioned achievement;

WHEREAS, in recognition of their exemplary performances in the various sporting events during the EVRAA 2016, this august body finds it highly proper to pass a resolution recognizing and congratulating the achievements of the Ormoc City athletes and coaches and for ranking third place among the thirteen delegations during the recent concluded Eastern Visayas Regional Athletic Association (EVRAA) 2016 held in Ormoc City and granting authority to the Honorable City Mayor to grant incentives and awards for their outstanding performances;

WHEREAS, this August body deems it appropriate that the abovestated incentives and awards are to be given to the athletes and coaches in the form of the following, to wit:

For the team each will receive the following:

- a) Gold - Php 20,000
- b) Silver - Php 18,000
- c) Bronze - Php 15,000

For the individual athlete each will receive the following:

- a) Gold - Php 5,000
- b) Silver - Php 3,000
- c) Bronze - Php 2,000

For the coaches they will be given Three Thousand Pesos (P 3,000.00) each. There were forty one (41) coaches whose athletes garnered medals during the recently concluded EVRAA 2016;
