RESOLUTION 2016-038

A RESOLUTION DECLARING THAT BARANGAY ORDINANCE NO. 2016-05 OF THE SANGGUNIANG BARANGAY OF BARANGAY DISTRICT XIII, THIS CITY, ENTITLED: "AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED THIRTEEN THOUSAND SIX HUNDRED NINETEEN PESOS AND 60/100 (P113,619.60) FOR CALENDAR YEAR 2016 TO COVER PROGRAMS AND EXPENDITURES OF THE YOUTH TASK FORCE ON YOUTH DEVELOPMENT FOR THE BUDGET YEAR", UNDER REVIEW HAS BEEN FOUND TO BE SUBSTANTIALLY IN CONFORMITY WITH EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, this august Body received a copy of Ordinance No. 2016-05 of Barangay District XIII, Ormoc City, entitled: "AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED THIRTEEN THOUSAND SIX HUNDRED NINETEEN PESOS AND 60/100 (P113,619.60) FOR CALENDAR YEAR 2016 TO COVER PROGRAMS AND EXPENDITURES OF THE YOUTH TASK FORCE ON YOUTH DEVELOPMENT FOR THE BUDGET YEAR", a copy of the Ordinance together with its attachments are hereto attached and made an integral part hereof;

WHEREAS, the aforesaid Ordinance was submitted to this Sanggunian pursuant to its review powers over enacted ordinances of all barangays within its territory as provided for in Section 57 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991" (LGC) in order to find out whether the subject Appropriation Budget Ordinance approved by the Sangguniang Barangay under review is in conformity with law and city ordinances;

WHEREAS, the Sangguniang Barangay of Barangay District XIII had enacted the subject Ordinance in accordance with the provisions of Republic Act No. 10656, otherwise known as "AN ACT POSTPONING THE SANGGUNIANG KABATAAN ELECTIONS TO THE LAST MONDAY OF OCTOBER 2016, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9164, AND FOR OTHER PURPOSES";

WHEREAS, pursuant to the Implementing Rules and Regulations (IRR) of Republic Act No. 10656, a Task Force on Youth in every barangay should be organized to formulate a Youth Development Plan (YDP), and to ensure that programs and projects in the Plan are implemented in the barangay and the Sangguniang Kabataan (SK) Funds in the barangay are utilized for youth development purposes;

WHEREAS, Rule 4 of said IRR provides that 10% of the general fund of the barangay allocated for SK shall be used by the Sangguniang Barangay solely for youth development programs or projects and in the conduct of SK elections until the new sets of SK officials have been duly elected and qualified;

WHEREAS, the Barangay Dist. XIII had approved their Barangay Annual Budget for the year 2016 and allocated the amount of ONE HUNDRED THIRTEEN THOUSAND SIX HUNDRED NINETEEN PESOS AND 60/100 (P113,619.60) to cover programs and expenditures of the task force on youth development as contained in the Barangay's YDP;

WHEREAS, this Sanggunian in the exercise of its said review powers, and after thorough examination of the subject Ordinance, finds that the same is indeed in conformity and compliance with existing applicable laws and city ordinances, that the Ordinance was actually passed in the spirit of transparency so that the constituency of the barangay will know how the barangay funds will be spent and to ensure that it was in furtherance of the intents of the applicable laws, which in this case is for the furtherance of the promotion and development of the Barangay's youth and finally, this august Body believes that the subject Ordinance has an additional noble purpose in that it aims to fully comply with the provisions of said IRR and, therefore, is most deserving of this august Body's approval and its declaration of interposition of no objection to its implementation;

WHEREFORE, on motion of the Honorable SP Member Benjamin S. Pongos, Jr. Chairman, Committee on Laws and Ordinances, severally seconded by the Honorable SP Members Tomas R. Serafica, Ruben R. Capahi, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Gerardo S. Penserga, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it
