A RESOLUTION APPROVING THE APPLICATION FOR  
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF  
ORMOC IN ACCORDANCE WITH THE PROVISIONS OF  
ORDINANCE NO.009 DATED OCTOBER 16, 2014 OF THE  
FOLLOWING CIVIL SOCIETY ORGANIZATIONS (CSOs), TO  
WIT:

1. REBOLUSYONARYONG ALYANSANG MAKABANSA (RAM)
2. GREEN VALLEY FARMERS ASSOCIATION (GREVAFA)

WHEREAS, this Fourteenth Sangguniang Panlungsod ng Ormoc received the applications of Rebolusyonaryong Alyansang Makabansa (RAM) and Green Valley Farmers Association (GREVAFA), both are Civil Society Organizations (CSOs) requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, RAM is an organization composed of military personnel and other civilian people which is registered with the Securities and Exchange Commission (SEC) while GREVAFA is an organization of local farmers in Barangay Green Valley, this city, registered with the Department of Labor and Employment (DOLE) ;

WHEREAS, both organizations are guided with the thrust of working with the local government as well as with other non-government organizations in the promotion of peace and order, development of local resources, and in carrying out government issues, policies and programs for inclusive growth;

WHEREAS, the call for Accreditation of CSOs was pushed by this Sanggunian in accordance with the Ordinance No. 009 dated October 16, 2014 entitled: " AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which ordinance provides for the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) day period within which application for accreditation for membership in Local Special Bodies by any organization shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforementioned applications submitted by RAM and GREVAFA, finds that the same are in order and the purpose of the sought accreditation is for the realization of the thrust of the aforementioned organizations to assist and work hand in hand with the LGU in various areas of concern and to actively participate in the implementation of projects and programs that has positive impact to its members;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by SP Members Tomas R. Serafica, Benjamin S. Pongos, Jr., Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it


