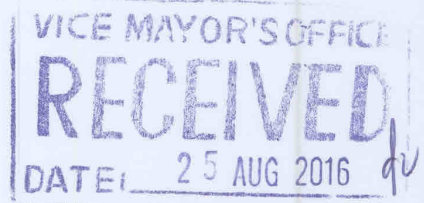

RESOLUTION NO. 2016-040

A RESOLUTION AUTHORIZING ORMOC CITY MAYOR RICHARD  
I. GOMEZ, REPRESENTING THE ORMOC CITY  
GOVERNMENT, TO ENTER INTO AND SIGN A  
MEMORANDUM OF AGREEMENT (MOA) WITH ALL THE  
BOTTOM UP BUDGETING (BUB) PARTICIPATING AGENCIES  
AND PROJECTS.

WHEREAS, this august Body was in receipt of an Indorsement dated August 9, 2016 from the Office of the City Mayor requesting the passage of a resolution to grant authority to the City Mayor Richard I. Gomez to enter and sign a Memorandum of Agreement (MOA) relative to the implementation of various Bottom-Up Budgeting (BuB) Projects, a photocopy of the final and revised MOA of which is hereto attached and made an integral part thereof;

WHEREAS, pursuant to the DBM-DILG-DSWD-NAPC Joint Memorandum Circular 07, series of 2015, issued on November 3, 2015, specifying the policy guidelines and procedures for the implementation of the BUB program for the FY2016 and thereafter, both the DWSD and the Local Government Unit (LGU) and/or Civil Society Organizations (CSO) shall uphold the principle of people empowerment even during the course of and post-project implementation;

WHEREAS, in pursuit of attaining the Philippine Development Plan's goal of inclusive growth and poverty reduction, and promoting good governance at the local level, the implementation of BuB projects are deemed a priority for this Administration;

WHEREAS, there is a need to pass a resolution granting a blanket authority to the City Mayor to enter and sign for and on behalf of the City Government of Ormoc in the implementation of the various BuB projects so as to facilitate the swift and smooth operation of all projects for the advancement of our City and the betterment of all its constituents;


ADOPTED, August 25, 2016.
