## RESOLUTION NO. 2016-042

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE COMMISSION ON POPULATION (POPCOM) REGIONAL OFFICE VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, MS. ELNORA R. PULMA, FOR THE TRANSFER OF OWNERSHIP AND ACCOUNTABILITY OF ONE (1) UNIT DESKTOP COMPUTER TO BE PLACED AND USED BY THE CITY POPULATION OFFICE.

WHEREAS, an Indorsement was received by this august Body dated March 8, 2016 from the Honorable City Mayor Edward C. Codilla recommending for the passage of a resolution authorizing His Honor to enter into and sign a Memorandum of Agreement (MOA) by and between the Local Government Unit of Ormoc (LGU-ORMOC), and the POPCOM Regional Office VIII, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the MOA deals with the transfer of ownership and accountability of one (1) unit Desktop Computer by the POPCOM Regional Office VIII to the City Population Office of LGU-Ormoc, which equipment shall be placed and used by the City Population Office in the accomplishment of their tasks and functions as population structure in the city;

WHEREAS, the POPCOM is a government agency mandated as the over-all coordinating, monitoring and policy making body of the population program as well as the lead agency in promoting population activities under the Philippine Population Management Program (PPMP);

WHEREAS, LGU-ORMOC which is actively participating in the population program shall properly utilize the equipment in furtherance of the same and shall shoulder the repair and maintenance expenses of the property including the provision of internet connectivity for online encoding and data base system;

WHEREAS, the parties abiding by the common bond of public service and dedication to achieve an effective population program have mutually agreed to effect the transfer of ownership and accountability of the equipment and perform their corresponding specific obligations and responsibilities, as stipulated in the MOA, and this Sanggunian finds, after close and thorough review of the same, that it is indeed beneficial to the city particularly to the City Population Office, and so therefore, most deserving of this august body's utmost support and favorable consideration;
