A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE MARITIME *INDUSTRY* ANTHORITY (MARINA) REPRESENTED BY ITS OFFICER -IN-CHARGE, ENGR. MARISTEL E. LETIGIO, FOR THE OCCUPANCY BY THE MARINA REGIONAL OFFICE VIII / ORMOC SATELLITE OFFICE OF A PORTION OF THE CITY TOURISM BUILDING LOCATED AT EBONY STREET, PORT AREA, THIS CITY.

WHEREAS, this august Body was in receipt of an Indorsement dated February 26, 2016 from the Honorable City Mayor Edward C. Codilla, recommending for the passage of a resolution authorizing His Honor to enter into and sign the MOA for and on behalf of LGU-Ormoc with the MARINA RO VIII, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the MARINA RO VIII is a government agency tasked with the development, promotion, regulation and supervision of the maritime industry in Eastern Visayas Region;

WHEREAS, the MARINA RO VIII desires to occupy a portion of the City Tourism Building located at Ebony Street, Port Area, this City, as their Satellite Office;

WHEREAS, as provided for in the MOA, the LGU-Ormoc will allow the MARINA RO VIII / Ormoc Satellite Office to occupy without rent/ or free of charge a portion of the City Tourism Building, with an area of at least 18.21 square meters, but the parties to the MOA agreed, however, that MARINA shall keep the property in good condition and shall take good care of the premises with diligence and further undertake minor repairs at its own expense without the benefit of reimbursement including major repairs;

WHEREAS, further, the MOA stipulates that the connection of the utilities such as electricity, water, telephone, among others and all corresponding bills therefore shall be the responsibility and account of MARINA RO VIII;

WHEREAS, the subject MOA had undergone review by the City Legal Officer who come up with a recommendation that there is no legal impediment for its execution and for this Sanggunian to pass the appropriate resolution authorizing the Honorable City Mayor to sign the same;

WHEREAS, the parties thereto have agreed to abide with the conditions set forth in the MOA for the occupancy of MARINA RO VIII, of a portion of the City Tourism Building as their Satellite Office and perform their corresponding specific obligations and responsibilities, and this Sanggunian finds, after close and thorough review of the same, that it is indeed not contrary to law, public morals and policy and so therefore, most deserving of this august body's utmost support and favorable consideration;
