A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BENALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE FOLLOWING : DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), DEPARTMENT OF HEALTH (DOH), DEPARTMENT OF EDUCATION (DepEd), DEPARTMENT OF SOCIAL WELFARE **DEPARTMENT DEVELOPMENT** AND (DSWD),RESOURCES ENVIRONMENT AND NATURAL (DENR), OF **DEPARTMENT AGRICULTURE** (DA),**TECHNICAL** AND DEVELOPMENT EDUCATION SKILLS AUTHORITY (TESDA), DEPARTMENT OF AGRICULTURE-BUREAU OF FISHERIES AND AQUATIC RESOURCES (DA-BFAR), DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE), AND NATIONAL ANTI POVERTY-COMMISSION (NAPC), AS IMPLEMENTING AGENCIES TO ENSURE THE SMOOTH IMPLEMENTATION OF BUB PROJECTS IN ORMOC CITY FOR CY 2016.

WHEREAS, this august Body was in receipt of an Urgent Indorsement dated March 8, 2016 from the Honorable City Mayor Edward C. Codilla, requesting for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign the Memorandum of Agreement (MOA) for and on behalf of LGU-Ormoc with the abovementioned agencies for the smooth implementation of the Bottom-Up Budgeting (BuB) Projects in Ormoc City for CY 2016;

WHEREAS, through a communication dated February 19, 2016, the OIC-CLGOO, DILG, Lucia C. Ong, had informed the Honorable City Mayor that the resolution previously passed by this Sanggunian approving the Local Poverty Reduction Action Plan (LPRAP) bearing the list of priority projects under BuB of LGU-Ormoc for FY 2016 denominated as SP Resolution No. 2014-231 does not provide an authorization for the Honorable City Mayor to enter into a MOA with all the concerned BuB Projects implementing agencies;

WHEREAS, as emphasized by Ms. Ong, in order to facilitate and ensure the smooth implementation of said Bub Priority Projects for FY 2016 as embodied in SP Resolution 2014-231, the Honorable City Mayor through a Sanggunian resolution should be given authority to enter into a MOA with the various project implementing agencies hence, this request from the Office of the City Mayor:

WHEREAS, a copy of the Local Poverty Reduction Action Plan (LPRAP) 2016 List of Priority Poverty Reduction Projects within Grassroots Budgeting Menu of Programs(BuB) indicating the respective implementing agency for each project is hereto attached and made an integral part hereof;

WHEREAS, this matter has passed through the Office of the City Legal Officer, Atty. Ivan Verallo, with the findings in an indorsement dated March 7, 2016 by said office that there is no legal impediment to implement the same and therefore recommending for the passage of a resolution authorizing the City Mayor to sign the MOA;

WHEREAS, the concerned parties to the MOA are mutually committed in collaborating for the smooth implementation of BuB projects for CY 2016 in the city in accordance with the provisions of the law, subject to their corresponding specific obligations and responsibilities, and this Sanggunian finds, after close and thorough review of the same, that the MOA is not contrary to law, existing contract and public morals, and that its goals are indeed beneficial for the city as the different BuB projects to be implemented are envisioned to move forward the development of each identified project beneficiaries and so therefore, most deserving of this august body's full and prompt support and favorable action;
