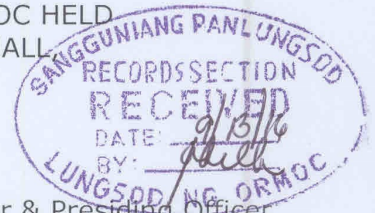

AN OMMIBUS RESOLUTION APPROVING THE THREE (3)
SEPARATE APPLICATIONS FOR ACCREDITATION WITH
THE LOCAL GOVERNMENT UNIT OF ORMOC, IN
ACCORDANCE WITH THE PROVISIONS OF ORDINANCE
NO. 009 DATED OCTOBER 16, 2014 OF THE FOLLOWING
CIVIL SOCIETY ORGANIZATIONS, TO WIT:

1. MARGEN FARMERS ASSOCIATION (MARFA)
2. UPTOWN VILLAGE HOMEOWNER'S ASSOCIATION, INC.
(UVHOAI)
3. ORMOC SUGARCANE PLANTERS ASSOCIATION, INC.
(OSPA)

WHEREAS, this Sanggunian received the applications for accreditation
with the Local Government Unit of Ormoc of the following Civil Society
Organizations (CSOs), to wit:

1. MARGEN FARMERS ASSOCIATION (MARFA)
2. UPTOWN VILLAGE HOMEOWNER'S ASSOCIATION, INC. (UVHOAI)
3. ORMOC SUGARCANE PLANTERS ASSOCIATION, INC. (OSPA)

WHEREAS, MARFA is an organization composed of farmers residing in Barangay Margen, this City, and is known to be an LGU-accredited CSO. It is presently requesting for re-accreditation with the Local Government Unit of Ormoc and among its objectives is to provide mutual aid and support to its members, and develop sustainable livelihood thru the adoption of organic farming as well as equip its member with knowledge and skills for effective and innovative way of farming;

WHEREAS, UVHOAI, a Homeowners Association of Brgy. Alta Vista, is also an LGU-accredited CSO that is currently seeking for re-accreditation with LGU-Ormoc. Among its primary concern is to facilitate the delivery of adequate social services and promote, enhance and foster the development and quality of life of the association members through livelihood projects and other economic activities;

WHEREAS, OSPA Inc. is a non-stock, non-profit association of businessmen engaged in sugarcane growing, comprising mostly of sugarcane planters from Ormoc City and its neighboring municipalities. Among its thrusts is to uplift the welfare of the sugarcane industry and generally the economic interest of the Philippines;

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforesaid applications, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of the SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, severally seconded by the SP Members Tomas R. Serafica, Lea Doris C. Villar, Nolito M. Quilang, Gregorio G. Yrastorza III, John Eulalio Nepomuceno O. Aparis II, Mariano Y. Corro and Mario M. Rodriguez; be it
