A RESOLUTION GIVING CONCURRENCE TO THE APPOINTMENT

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received an Urgent Indorsement dated March 4, 2016 from the Honorable City Mayor Edward C. Codilla on the matter of the appointment of Mrs. Hilda H. Lisondra as City Government Department Head I (City Accountant) for the City Government of Ormoc effective March 4, 2016, requesting for the concurrence by this Sanggunian;

WHEREAS, said appointment concurrence request was made in accordance with Section 454 Paragraph (D) of Chapter 2 (City Officials in General) of R.A. 7160, otherwise known as the Local Government Code of 1991, which provides that:

"X X X, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of the Sangguniang Panlungsod Members, subject to civil service law, rules and regulations. X X X X X"(Underscoring supplied).


