RESOLUTION NO. 2016-052

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE GENERAL MEMORANDUM OF AGREEMENT (GENERAL MOA) AND SPECIFIC IMPLEMENTATION AGREEMENT (SIA), FOR AND SWEETHALF OF THE LOCAL GOVERNMENT UNIT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), FIELD OFFICE VIII, REPRESENTED BY ITS REGIONAL DIRECTOR, MR. RESTITUTO B. MACUTO FOR THE DEVELOPMENT AND IMPLEMENTATION OF SOCIAL PROTECTION PROGRAMS THAT WILL ADDRESS THE NEEDS OF THE POOR, EMPOWER CITIZENS AND PROMOTE INCLUSIVE GROWTH IN THE CITY.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated August 9, 2016, requesting therein for the passage of a resolution granting authority to the City Mayor Richard I. Gomez to enter into and sign the General MOA and SIA, for and on behalf of the LGU-ORMOC with the DSWD Field Office VIII which is aimed to develop and implement social protection programs that will address the needs of the poor, empower citizens and promote inclusive growth in the city, photocopies of the final General MOA and SIA are hereto attached and made an integral part hereof;

WHEREAS, DSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families, communities are empowered for an improved quality of life and takes protection of the poor and marginalized members of society as its main concern;

WHEREAS, the Department, in the pursuit of its vision to operationalize its "Social Protection Mission", adopts a "Whole of DSWD" approach in ensuring convergence in implementation of its various strategies, programs, projects, activities to address the needs of the poor;

WHEREAS, as provided in the Local Government Code of 1991, Local Government Units (LGUs) are mandated to address the needs of its constituents, empower the people through direct participation in the affairs of the LGU by allowing them the widest possible space to decide on, initiate, implement, and innovate on development activities that address their identified needs;

WHEREAS, the City of Ormoc recognizes its role in ensuring inclusive development, and commits to address the needs of the poor within its jurisdiction and to deliver a package of services to address poverty, empower citizens and promote inclusive growth in the city and agree to commit each other to such partnership through the General MOA;

WHEREAS, the General MOA provides for the specific responsibilities to be carried out by the parties, namely the DSWD and the LGU-Ormoc, and that both shall enter into the voluntary commitment which aims to establish the execution of the SIAs;

WHEREAS, the SIA specifically states that the DSWD, through the Protective Service Unit (PSU), Kapit-Bisig Laban sa Kahirapan - Comprehensive and Integrated Delivery of Social Services (KALAHI-CIDSS) and Sutainable Livelihood Program (SLP), assists the Human Development and Poverty Reduction Cluster (HDPRC) in the implementation of the pilot phase by facilitating the conduct of BUB Planning Activities;

WHEREAS, upon close and thorough review, this Sanggunian, finds that the MOA is not contrary to law and existing contracts, and that the purpose of such project is aimed at developing and implementing social protection programs that will address the needs of the poor, empower citizens and promote inclusive growth in the City so therefore, most deserving of this august Body's full support and affirmative action to the same;

WHEREFORE on motion of SP Member Nolito M. Quilang, Vice-Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, Eusebio Gerardo S. Penserga, Gregorio G. Yrastorza III, John Eulalio Napamuceno O. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it
