A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE SIX (6) SEPARATE MEMORANDUM OF AGREEMENTS (MOAS) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DENR - PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (DENR-PENRO), REGIONAL OFFICE NO. VIII, REPRESENTED BY ITS PENR OFFICER, RANULFO Q. ARBIOL, FOR THE 2ND YEAR MAINTENANCE AND PROTECTION FOR 2016 NATIONAL GREENING PROGRAM - BOTTOM - UP BUDGETING (NGP-BUB: REFORESTATION) IMPLEMENTED IN 2015 IN THE FOLLOWING BARANGAYS, TO WIT:

- 2. BARANGAY NAUNGAN (MANGROVES)
- 3. BARANGAY MAS-IN (FUEL WOOD)
- 4. BARANGAY CABINGTAN (AGROFORESTRY)

- 6. BARANGAY BAGONG (RATTAN)

WHEREAS, this august Body was in receipt of an Indorsement dated March 14, 2016 from the Honorable City Mayor Edward C. Codilla, recommending for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign the MOAs for and on behalf of LGU Ormoc with the DENR-PENRO, Regional Office No. VIII, a photocopy of the final MOAs are hereto attached and made an integral part hereof;

WHEREAS, the MOA covers the 2nd year maintenance and protection for 2016 National Greening Program – Bottom - up Budgeting (NGP-BuB: Reforestation) implemented in 2015 with the above enumerated Barangays;

WHEREAS, Executive Order No. 26 dated February 24, 2011 declares the implementation of the NGP as government priority for poverty reduction, food security, biodiversity conservation, and climate change mitigation and adaptation, and further prescribes the harmonization of all greening efforts and similar initiatives of the governments, private sector, LGUs, and civil society;

WHEREAS, LGU-Ormoc has signified its interest to participate in the NGP as called for under DENR Memorandum Circular No. 2013-06;

WHEREAS, as provided for in the agreements, the DENR shall make available financial assistance to the abovementioned barangays by tranches as stipulated in the MOAs and shall commence effective January 16, 2016 to December 31, 2016;

WHEREAS, the City Legal Officer, Atty. Ivan Veralio, through an indorsement dated March 10, 2016 has stated that there is no legal impediment to implement the same and therefore recommending for the passage of a resolution authorizing the City Mayor to sign the MQAs;

WHEREAS, the concerned parties to the MOA are mutually committed in collaborating for the 2nd year maintenance and protection for 2016 NGP-BuB: Reforestation in accordance with the provisions of the law, subject to their corresponding specific obligations and responsibilities, and this Sanggunian finds, after close and thorough review of the same, that the MOA is not contrary to law, existing contract and public morals, and that its goals are indeed extremely beneficial to the barangays and farmer beneficiaries and to the City as well and so therefore, most deserving of this august Body's full and prompt support and favorable action;
