RESOLUTION NO. 2016-056

A RESOLUTION APPROVING THE APPLICATION FOR  
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT  
OF ORMOC OF KAHUGPUNGAN SA MAG-UUMANG  
ORMOCANON INC. (KAMAO INC.), IN ACCORDANCE  
WITH THE PROVISIONS OF ORDINANCE NO.009 DATED  
OCTOBER 16, 2014.

WHEREAS, this august Body received the application of Kahugpungan sa Mag-uumang Ormocanon Inc. (KAMAO INC.), a Civil Society Organization (CSO), requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, KAMAO Inc., is a federation of Sixteen (16) community based Agrarian Reform Beneficiaries (ARB's), Small Farmers (SFs), Fisher Folk Association, aimed to protect and promote the rights and interests of the women, children, farmers & fisher folk to uplift their living conditions through organized and concerted actions;

WHEREAS, further, said organization was registered with the Securities and Exchange Commission (SEC) and it envisions a society of justice, freedom and democracy, where people are equipped with high self-respect and with the capability to live a decent life as well as empowered to participate decision making in society towards sustainable development;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this Sanggunian, after close and thorough review of the aforementioned application, finds that the same is in order, and the purpose of the sought accreditation is for the aforementioned organization to move forward its noble intention to promote moral, social and economic development among its members through the establishment of a strong linkage with the LGU for them to become a broad and strong federation in Ormoc City and in nearby areas that will advocate and implement genuine agrarian reform;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;

WHEREFORE, on motion of SP Member Eusebio Gerardo S. Penserga, Chairman, Committee on Accreditation, dully seconded by SP Members Lea Doris C. Villar and Mariano Y. Corro; be it


