A RESOLUTION APPROVING THE APPLICATION FOR
ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT
OF ORMOC OF MARGEN FARMERS ASSOCIATION (MARFA)
IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE
NO.009 DATED OCTOBER 16, 2014.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received the application of Margen Farmers Association (MARFA), a Civil Society Organization (CSO) composed of farmers residing in Barangay Margen, Ormoc City, requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: " AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for Accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) day period within which application for accreditation for membership in Local Special Bodies by any organization shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforementioned application, finds that the same is in order and the purpose of the sought accreditation is for the aforementioned organization to move forward its noble intention to promote mutual aid, protection, and socio-economic development among its members through the establishment of a strong linkage with the LGU in order for the association to have a better access to future agricultural programs of the government that are beneficial to its members;
