

BOXING FEDERATION (IBF) FLYWEIGHT TITLE AT THE O2
ARENA (MILLENNIUM DOME), GREENWICH, LONDON,
UNITED KINGDOM ON SEPTEMBER 10, 2016 AND
LIKewise, EXTENDING FINANCIAL INCENTIVE IN THE
AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) IN
RECOGNITION OF HIS EXEMPLARY PERFORMANCE.*

WHEREAS, John Riel R. Casimero, 26 years old, a professional boxer, is a true-blooded son of Brgy. San Antonio, Ormoc City;

WHEREAS, John Riel R. Casimero, nicknamed "QUADRO ALAS", has held the following belts in his young professional boxing career: Philippines Boxing Federation (PBF) Flyweight Title (August 2008), WBO Asia Pacific Light Flyweight Title (October 2008-2009), Interim WBO Light Flyweight Title (December 2009-July 2010), Interim IBF Light Flyweight Title (February 2012 - July 2012), IBF Light Flyweight Title (2012-2014), and currently holds the IBF Flyweight Title (2016);

WHEREAS, the Filipino Champ gave a rousing performance by successfully defending his IBF Flyweight Title via a 10th round Knock-Out (KO) against British fighter Charlie Edwards at the O2 Arena (Millennium Dome) Greenwich, London, United Kingdom on September 10, 2016;

WHEREAS, such win has raised his career record to an astounding 23 wins and only 3 losses, 15 of which were won via technical knockout;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be it


