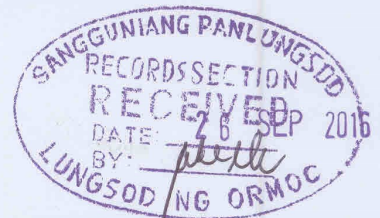

RESOLUTION NO. 2016-058

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN A CONTRACT OF SERVICE (RENEWAL) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF HEALTH (DOH), REPRESENTED BY ITS REGIONAL DIRECTOR, DR. MINERVA P. MOLON AND MS. SHARMAIN GALENZOGA (MIDWIFE) FOR THE CONTINUING IMPLEMENTATION OF THE DOH RURAL HEALTH MIDWIVES PLACEMENT PROGRAM (RHMPP).

WHEREAS, this Sanggunian was in receipt of an Indorsement dated September 5, 2016 from the Office of the City Mayor regarding the Indorsement from the City Health Officer II, Dr. Nelita D. Navales, recommending for the passage of a resolution authorizing the City Mayor Richard I. Gomez, to enter into and sign the renewal Contract of Service for and on behalf of LGU-Ormoc with the DOH and Ms. Sharmain Galenzoga, a photocopy of the final Contract of Service of which is hereto attached and made an integral part hereof;

WHEREAS, the subject Contract of Service is for the continuous implementation of the DOH Rural Health Midwives Placement Program (RHMPP) furthermore, particularly covering the "Return Service" of Ms. Sharmain Galenzoga in Ormoc City in relation to her 2-year Midwifery Scholarship from the DOH-RHMPP which she agreed to serve and render service within a period of four (4) years upon completion of the said scholarship grant;

WHEREAS, it can be recalled that this Sanggunian had already acted on Four (4) SP Resolutions regarding the Contract for the "Return Service" of Ms. Sharmain Galenzoga, covering four cycles of her "Return Service" which duration of each cycle is good for Six (6) months only, the latest of which is SP Resolution No. 2016-029 dated February 25, 2015 which dealt with the preceding contract of Ms. Galenzoga for the period January 2016 to June 2016, renewable every six (6) months of service;

WHEREAS, with the expiration of the previous Contract, and considering that the parties to the Contract of Service mutually agreed for the continuing implementation of said "Return Service" of Ms. Galenzoga in Ormoc City, there is a need for the approval of this Renewal of Contract to be approved so that it can be implemented in accordance with the terms and conditions set forth thereon;

WHEREAS, upon close and thorough review of the current contract, this Sanggunian finds the provisions to be in proper form and order, that it is not contrary to law, contract, public policy and public morals, that the period being covered is also good for another Six (6) months effective July 1, 2016 until December 30, 2016, and further, this august Body deems that the same is indeed beneficial to the City of Ormoc as the continued engagement of the services of Ms. Galenzoga will augment the City Health Office workforce specifically in the area of delivery of midwives' health services, whose salary shall be paid by the DOH;

WHEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II, Gregorio G. Yrastoraza III, Tomas R. Serafica and Eusebio Gerardo S. Penserga; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. 
RESOLVED, FURTHER, that a copy of the final and notarized Contract of Service be submitted to this sanggunian for its information and files;
