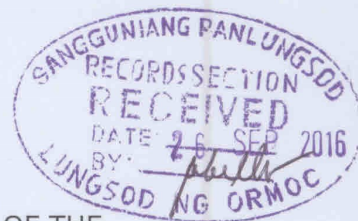

A RESOLUTION APPROVING THE CHANGING OF THE  
PROPOSED LOCATION OF THE BUB 2015 DEPARTMENT OF  
TOURISM PROJECTS AS PER LOCAL POVERTY REDUCTION  
ACTION TEAM (LPRAT) RESOLUTION NO. 2016-005 DATED  
AUGUST 16, 2016.

WHEREAS, the Local Poverty Reduction Action Team (LPRAT) of Ormoc City has formulated its Local Poverty Reduction Action Plans (LPRAPs) of the City for 2014, 2015, 2016 and 2017, indicating therein priority poverty reduction projects, duly endorsed by CSO representatives;

WHEREAS, some of the projects in the LPRAP 2015 are under the Department of Tourism and that two of these projects need their locations changed as they cannot be pursued due to security and location concerns;
