RESOLUTION NO. 2016-062

A RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE RENEWAL OF MEMORANDUM OF AGREEMENT (MOA), FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ORMOC (LGU-ORMOC), WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), REPRESENTED BY MICHAEL RODRIGO I. MONDOY, SENIOR MANAGER, HEAD, ORMOC BRANCH FOR THE INSTALLATION OF ONE (1) UNIT AUTOMATED TELLERING MACHINE (ATM) AT THE ENTRANCE LOBBY AT THE BACK OF THE NEW ORMOC CITY HALL BUILDING.

WHEREAS, this august Body was in receipt of an Indorsement from the Office of the City Mayor dated September 8, 2016 pertaining to the MOA to be entered into by LGU-Ormoc with the DBP, represented by Michael Rodrigo I. Mondoy, Senior Manager, Head, Ormoc City Branch, and further requesting authority for the City Mayor Richard I. Gomez to sign the said renewal MOA for and on behalf of LGU-Ormoc, for the Installation of One (1) Unit ATM Machine, a photocopy of the final MOA and its annex is hereto attached and made an integral part hereof;

WHEREAS, the MOA refers to the continued operation of one (1) unit ATM located at the entrance lobby at the back of the New Ormoc City Hall at Aunubing St., Brgy. Cogon, Ormoc City, as one of DBP's programs which aimed at bringing its products and services to reach out to clients;

WHEREAS, to recall, there was a previous agreement covering this matter as approved by the Sanggunian per SP. Res. No. 2014-137 dated August 14, 2014 but in view of its expiration and considering that DBP-Ormoc Branch still desires to continue occupying the subject premises in its aim to respond to the need for ATM services of the LGU-Ormoc officials and employees, as well as visitors and other guests who wish to avail of said services, there is a need to renew the agreement concerning the matter;

WHEREAS, the LGU-Ormoc, in further response to said DBP noble program, will allow the DBP to occupy free of charge, a portion of the ground floor of the New Ormoc City Hall Building located in Barangay Cogon, Ormoc City, a total floor area of Ten (10) square-meters for one (1) ATM for a period of one (1) year, but the parties to the MOA agree, however, that DBP shall shoulder the ATM monthly electricity consumption which is fixed at One Thousand Five Hundred Philippine Pesos (PhP1,500.00);

WHEREAS, the parties thereto have agreed to abide with the conditions set forth in the MOA for the installation of one (1) unit ATM, at a portion of the entrance lobby at the back of the New City Hall Building and perform their corresponding specific obligations and responsibilities, and this Sanggunian finds, after close and thorough review of the same, that it is indeed not contrary to law, public morals and policy and so therefore, most deserving of this august body's utmost support and favorable consideration;

WHEREFORE, on motion of SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Mariano Y. Corro, Lea Doris C. Villar, John Eulalio Nepomuceno O. Aparis II, Gregorio D. Yrastorza III, Eusebio Gerardo S. Penserga and Tomas R. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE CITY MAYOR RICHARD I. GOMEZ TO ENTER INTO AND SIGN THE RENEWAL OF MEMORANDUM OF AGREEMENT (MOA), FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ORMOC (LGU-ORMOC), WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), REPRESENTED BY MICHAEL RODRIGO I. RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this Sanggunian for its information and files;


