## RESOLUTION NO. 2016-063

- OMNIBUS RESOLUTION APPROVING THE SIX (6) SEPARATE APPLICATIONS FOR ACCREDITATION WITH LOCAL GOVERNMENT UNIT OF ORMOC, IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 209 DATED OCTOBER 16, 2014 OF THE FOLLOWING CIVIL SOCIETY ORGANIZATIONS, TO WIT:
  - 1) ORMOC SOUTH DISTRICT FARMER-IRRIGATORS SERVICE COOPERATIVE (OSDI FISCO)
  - KASANAG FARMER-IRRIGATORS MULTI PURPOSE COOPERATIVE (KASANAG FIMPCO)
  - 3) PHILNET FOR RURAL DEMOCRATIZATION AND DEVELOMENT, INC. (PHILNET INC.)
  - 4) KALIHUKAN ALANG SA BAG-ONG ORMOC (KAABAG-ORMOC), INC.
  - 5) SITIO CATMONAY VEGETABLE FARMERS ASSOCIATION (SICAVFA)

## 6) VALENCIA AGRARIAN SMALL FARMERS ASSOCIATION (VASFA)

WHEREAS, this august Body received the applications for accreditation with the Local Government Unit of Ormoc of the above-enumerated Civil Society Organizations (CSOs);

WHEREAS, OSDI FISCO, is an organization registered with the Cooperative Development Authority (CDA) which purpose is to undertake the operation and maintenance of South Main Canal, Lat D & Lat D1 irrigation canal under Bao River Irrigation System as well as to engage in management support services for irrigated agriculture such as facilitation of credit, provision of agricultural inputs and post harvest facilities to its members;

WHEREAS, KASANAG FIMPCO, is a primary multi-purpose cooperative of Brgy. San Jose, this City, registered under the Cooperative Development Authority (CDA) which one of the objectives is to undertake programs and activities related to irrigation, lending, marketing of agricultural farm inputs, and crop protection in order to increase the farmer members production and income;

WHEREAS, PHILNET Inc., is an LGU-accredited CSO that is currently seeking for re-accreditation with LGU-Ormoc, registered with the Securities and Exchange Commission (SEC). One of its programs is cultivating Agro-biodiversity in Building Climate-Resistant and Disaster-Resilient Model Barangays in Ormoc, Leyte (CA Builds Back Ormoc) funded by the Christian Aid;

WHEREAS, KAABAG ORMOC, was established with its primary purpose to change Ormoc into a City of values-driven and empowered citizens working together for a well governed community, committed to solutions and create opportunities that will ensure a progressive Ormoc, said association is registered with the Securities and Exchange Commission (SEC);

WHEREAS, SICAVEA is an association composed of farmers residing in Brgy. Cabintan, Ormoc City, registered under DOLE-Western Leyte Field Office (WLFO). Among its concern is to develop a sustainable livelihood thru the conduct of activities with the aim of uplifting the economic condition of its members;

WHERE 3, VASFA, an organization of small farmers in Brgy. Valencia, is registered with DOLE-WLFO, with its purpose to assist members who are Agrarian Reform Beneficiaries in acquiring the land awarded to them, assist the tenant farmer-members in acquiring security of tenure of the land they till and claim support services through Agrarian Reform Programs of the Government;

WHEREAS, the call for accreditation of CSOs was pushed by this Sanggunian in accordance with the provisions of Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No. 009 provides among others that an organization may still be accredited after the prescribed sixty (60) – day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforesaid applications, finds that the same are in order, and the purposes of the sought accreditation are all directed to promote mutual aid, protection, and socio-economic development among its members through the establishment of a strong linkage with the LGU in order for each organization to have a better access to the diverse programs and projects of the government that are beneficial to all sectors of the community;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No. 009 hence, most deserving of favorable action by this Sanggunian;
