WHEREAS, the City Government of Ormoc has a pending insurance claim with the Government Service Insurance System (GSIS) in connection with the damage to its infrastructures wrought by Typhoon Yolanda last November 8, 2013;

WHEREAS, in relation thereto, this 13th Sangguniang Panlungsod ng Ormoc received an Indorsement from the Honorable City Mayor Edward C. Codilla which sought this august Body's comments as regards the GSIS settlement proposal covering the properties of the city which were insured with the GSIS;

WHEREAS, in order to arrive at a well-informed decision on the matter, this Body had requested representatives from the GSIS to make a comprehensive presentation as regards their settlement proposal;

WHEREAS, to further secure the interest of the city, and so as to ensure that we are getting a fair and reasonable settlement from the GSIS, the Sanggunian sought the expert opinion of a private insurance practitioner and requested him to evaluate the proposal of the GSIS;

WHEREAS, the insurance practitioner consulted by the Sanggunian made a thorough review of the proposal of the GSIS and rendered his evaluation, which was to the effect that the said proposal was fair and reasonable;
