RESOLUTION NO. 2016-066

A RESOLUTION APPROVING THE PURCHASE OF ONE (1) UNIT  
MULTI-PURPOSE VEHICLE (MPV) AND ONE (1) UNIT  
SPORTS UTILITY VEHICLE (SUV) TO BE UTILIZED AS  
SERVICE VEHICLES FOR THE SANGGUNIANG  
PANLUNGSOD NG ORMOC.

WHEREAS, the City Vice Mayor & Presiding Officer, Leo Carmelo L. Locsin, Jr., in his endeavors to enhance the business operations of the legislative body, intends to acquire/purchase One (1) unit Multi-Purpose Vehicle (MPV), diesel fed, with an Engine Displacement of 2477 CC and One (1) unit Sports Utility Vehicle (SUV), 2.8 E Diesel Manual Transmission with an engine displacement of 2798 CC, necessary to fast track government transactions and for a more convenient mobilization of the Members of the Sangguniang Panlungsod;

WHEREAS, this matter had already been referred to the Office of the City Mayor Richard I. Gomez and had the approval of the City Mayor as the proposed vehicle purchase is consistent with the thrust of the SP and within the scope of the LGU's object of expenditures for CY 2015 and 2016 as authorized through Appropriation Ordinance Nos. 2015-001 and 2016-001;

WHEREAS, DILG MC No. 2014-155 provides for the "Guidelines on the Motor Vehicles Acquisition by LGU's". Under item (3) paragraph (3.3) of the aforesaid DILG MC, it was clearly stated that the LGU shall seek the approval of the Secretary of Interior and Local Government (SILG) for the acquisition of motor vehicles, whose specifications are within the prescribed standards as enumerated in subparagraph 3.3.1 to 3.3.4 thereof;



WHEREAS, considering that the specifications of the proposed vehicles to be purchased are within the standards set by DILG-MC 2014-155 specifically in subparagraph 3.3.3 to 3.3.4, there is a need for this matter to be forwarded to the DILG for approval and issuance of authority to purchase said vehicles;

WHEREAS, further, one of the requirements set forth in DILG MC 2014-155 is a local measure approving such purchase, thus, this Sanggunian resolves to pass this resolution to effect the proposed purchase of service vehicles, it being beneficial to public service and being not contrary to law, public policy and morals and therefore, is most deserving of the august Body's full support;

FOREGOING PREMISES CONSIDERED, on motion of SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, severally seconded by SP Members Tomas R. Serafica, Nolito M. Quilang, John Eulalio Nepomuceno O. Aparis II and Mariano Y. Corro; be it


