CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE FOLLOWING: DEPARTMENT OF TRALE AND INDUSTRY - LEYTE, REPRESENTED BY ITS PROVINCIAL DIRECTOR, DESIDERIO P. BELAS, JR., LOCAL SMALL AND MEDIUM ENTERPRISE DEVELOPMENT (SMED) COUNCIL OF ORMOC CITY, ORMOC CITY CHAMBER OF COMMERCE AND INDUSTRY, REPRESENTED BY ITS CLUB PRESIDENT, MR. JUDE ABENOJA, AND WESTERN LEYTE COLLEGE OF ORMOC CITY, REPRESENTED BY ITS CAMPUS PRESIDENT, MR. EMMANUEL A. FIEL, FOR THE OPERATION OF NEGOSYO CENTER HOSTED BY LGU-ORMOC.

WHEREAS, this august Body was in receipt of an Indorsement dated April 12, 2016 from the Honorable City Mayor Edward C. Codilla, requesting for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign the Memorandum of Agreement (MOA) for and on behalf of LGU-Ormoc with the aforementioned various stakeholders for the operation of the LGU hosted NEGOSYO CENTER, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the DTI Provincial Director, Desiderio P. Belas, Jr., through a communication dated March 15, 2016, is extending its deepest gratitude to LGU-Ormoc for its active involvement on the continuing effort of Micro, Small and Medium Enterprises (MSMEs) development and promotion in Ormoc City for the establishment of Ormoc Negosyo Center, and further requesting for the passage of a resolution covering the matter as part of the documentary and legal requirements needed on the establishment of Ormoc Negosyo Center to help formalize and legalize relationship between the aforementioned Program partners;

WHEREAS, Republic Act 10644 otherwise known as the "Go Negosyo Act" promotes job generation and inclusive growth through the development of MSMEs which aims to bring closer the government services through the establishment of Negosyo Centers with its vision to nurture the growth of MSMEs and create an attractive framework to SMEs in dealing with the difficulties in the process of doing business and to alleviate the disadvantages that MSMEs encounter by providing numerous technical services that are useful in fostering innovation and entrepreneurship;

WHEREAS, further, the Go Negosyo Act mandates the creation of Negosyo Centers under the supervision of Micro, Small and Medium Enterprise Development (MSMED) Council, through the DTI, and said center shall be responsible for promoting ease of doing business and facilitating access to services for MSMEs within Ormoc City hence, the need also for the reconstitution of the Local SMED Council by the Honorable City Mayor in order to carry out the purposes of the MOA;

WHEREAS, the Negosyo Center with its general objectives to facilitate and assist MSME has three (3) main functions: (1) Business Name Registration; (2) Business Advisory Services; and (3) Business Information and Advocacy

WHEREAS, this matter has passed through the Office of the City Legal Officer, Atty. Ivan Verallo, with the findings in an indersement dated April 7, 2016 by said office that there is no legal impediment to implement the same and therefore recommending for the passage of a resolution authorizing the City Mayor to sign the MOA;

WHEREAS, the various stakeholders to the MOA are mutually committed in collaborating for the smooth operation of the Negosyo Center hosted by the LGU in accordance with the provisions of the law, subject to their corresponding specific obligations and responsibilities, and this Sanggunian finds, after close and thorough review of the same, that the MOA is not contrary to law, existing contract and public morals, and that its goals are indeed beneficial to the city and to its constituents and to therefore, most deserving of this august body's full and prompt support and favorable action;
