Ramirez, coached and managed by Antero Koykka competed in the Asian Powerlifting Championships held at Udaipur, India from June 6-12, 2016. A competition sanctioned by the International Powerlifting Federation, an organization that is officially recognized by the International Olympic Committee (IOC);

WHEREAS, representing the Philippines, the three Ormocanons, worthy of accolade, took home various medals in their respective class;
