A RESOLUTION GRANTING AUTHORITY TO THE CITY TRASURFR, MS. DELIA C. VILBAR AND THE OIC - CITY ADMINISTRATOR, MR. VINCENT L. EMNAS, AUTHORIZED SIGNATORIES, TO OPEN A NEW SPECIAL SAVINGS ACCOUNT OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) - ORMOC BRANCH, TO SERVE AS DEPOSITORY ACCOUNT FOR THE LGU-ORMOC INSURANCE CLAIM FROM GOVERNMENT INSURANCE SYSTEM (GSIS) AMOUNTING TO SEVENTY NINE MILLION SIX HUNDRED THREE THOUSAND TWO HUNDRED FOURTEEN PESOS & 17/100 (P79,603,214.17).

WHEREAS, this august Body was in receipt of an Indorsement dated September 14, 2016 from the Office of the City Mayor, with reference to the letter request from the City Treasurer, Ms. Delia C. Vilbar, for authority to open a new Special Savings Account of LGU-Ormoc with DBP, as depository account for its GSIS insurance claim;

WHEREAS, as laid down in the communication dated September 13, 2016, from the Office of the City Treasurer, LGU-Ormoc received from GSIS an amount of SEVENTY NINE MILLION SIX HUNDRED THREE THOUSAND TWO HUNDRED FOURTEEN PESOS & 17/100 (P79,603,214.17) representing LGU-Ormoc insurance claim in connection with the damaged properties during typhoon Yolanda which is currently deposited to its General Fund account at DBP earning only .25% per annum;

WHEREAS, based on the comparative computation from DBP, the aforementioned amount when invested to a Special Savings Account of the same bank, shall earn 1.4% to 1.5% interest per annum which is far more advantageous to the city as compared to the current .25% per annum;

WHEREAS, anent thereto, this Sanggunian finds, that the request is in accordance with the provisions of the law, public policy and morals and therefore, is most deserving of the august Body's full support and prompt favorable consideration to carry out the purpose of the City Treasurer;
