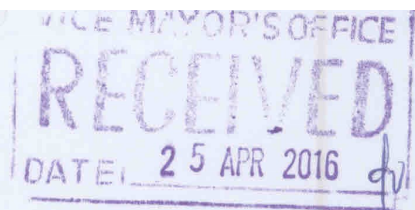

2. BARANGAY DISTRICT 14


