RESOLUTION NO. 2016-070

A RASOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. COMEZ FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO ENROLL IN ELECTRONIC PAYMENT AND COLLECTION FACILITIES (EPCF) OR E-GOV FACILITY OF THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) TO ACCOMMODATE PROCESSING AND REMITTANCES TO VARIOUS GOVERNMENT AGENCIES.

WHEREAS, Republic Act No. 8792, otherwise known as the 'Electronic Commerce Act of 2000', emphasizes the need to create an information-friendly environment which supports and ensures the availability, diversity and affordability of Information and Communications Technology (ICT) products and services;

WHEREAS, DBP's Electronic Government (eGov) services is an internetenabled electronic payment system which allows businesses and government institutions to perform online settlement of government contributions/payments to various government agencies such as the Philhealth, Pag-IBIG, SSS and BIR;

WHEREAS, DBP offered to the Local Government Unit of Ormoc (LGU-Ormoc) as a valued depositor, said eGov facility to handle government contributions/payments to SSS, Philhealth, Pag-IBIG, & BIR of its employees;

WHEREAS, with the system, filing and payment of contributions and payment of monthly loan amortizations to the selected government agencies can be done fast, easy and secured;

WHEREAS, the City Mayor Richard I. Gomez, through this Resolution, shall have authority to sign all documents necessary to subscribe to DBP eGov facility and designate authorized signatories to enroll and designate authorized user/s in the said facilities;

WHEREAS, in order to properly monitor the contributions/remittances, the authorized City personnel as official user/s for the account shall be covered by an office order from the responsible officer of the City;

WHEREAS, LGU-Ormoc will open and/or maintain a Current or Savings Account with DBP from where the contributions/ payments will be debited;

WHEREAS, in the exercise of his authority, the City Mayor shall have the power to amend, add, delete enrolled deposit account/s as source and/or destination account/s access rights to the eGov modules, authorization rules and/or any information on the original and succeeding enrollments;

WHEREAS, in order to avail of the said facility and system, a passage of this Resolution is deemed necessary and proper to expedite the processing of appropriate electronic transmission/s and to easily track down the history of payment, and it is the findings of this Sanggunian that said system will be beneficial to those who will avail of the same and therefore deserves to be accorded support and favorable action;

WHEREFORE, on motion of SP Member Benjamin S. Porgos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by SP Members Tomas R. Serafica, John Eulalio Nepomuceno Q. Aparis II, Lea Doris C. Villar and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a A RESOLUTION AUTHORIZING THE CITY MAYOR RICHARD I. GOMEZ, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), TO ENROLL IN ELECTRONIC PAYMENT AND COLLECTION FACILITIES (EPCF) OR E-GOV FACILITY OF THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) TO ACCOMMODATE PROCESSING AND REMITTANCES TO VARIOUS GOVERNMENT AGENCIES;
