RESOLUTION NO. 2016-072

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE THREE (3) SEPARATE MEMORANDUM OF AGREEMENTS (MOAs) BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC) AND THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) REPRESENTED BY PENR OFFICER RANULFO Q. ARBIOL FOR THE IMPLEMENTATION OF THE NATIONAL GREENING PROGRAM (NGP) IN BARANGAYS BAGONG, HIBUNAWON AND DOMONAR, ORMOC CITY.

WHEREAS, this sanggunian received three (3) separate indorsements from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor to enter into and sign for and on behalf of LGU-Ormoc the Memorandum of Agreements (MOAs) to be entered into by the LGU of Ormoc City with the Dept. of Environment and Natural Resources (DENR) regarding the implementation of the National Greening Program (NGP) in its three (3) barangays namely: Barangay Bagong, Barangay Hibunawon and Barangay Domonar ;

WHEREAS, the subject MOAs are in line with the Executive Order No. 26 dated February 24, 2011 which mandates for the implementation of a National Greening Program (NGP) as a government priority for poverty reduction, food security, biodiversity conservation, and climate change mitigation and adaptation and further prescribes for the harmonization of the greening efforts and similar initiatives of the governments, private sector, LGUs and the civil society;

WHEREAS, the goal of the partnership agreements is to accelerate/hasten the attainment of 1.5 billion seedling production and 1.5 million hectares plantation establishment nationwide at the end of 2016 as mandated in the NGP;

WHEREAS, the parties to the agreement collaborated their efforts to make possible the conduct and implementation of certain projects in support to NGP as follows:

1. Comprehensive Site Development (CSD) for NGP Plantation Established for CY 2016 to include the Seedling production of Timber fast growing species, site preparation and plantation establishment & One (1) year Maintenance & Protection covering forty (40) hectares to be located in Brgy. Bagong, Ormoc City - P540,000.00
2. Comprehensive Site Development (CSD) for NGP Plantation established for CY 2016 to include the Seedling production of Timber fast growing species, site preparation and plantation establishment & One (1) year Maintenance & Protection covering Seventy One (71) hectares to be located in Brgy. Hibunawon, Ormoc City - P958,500.00
3. Comprehensive Site Development (CSD) for NGP Plantation established for CY 2016 to include the Seedling production of Fruit Trees species, site preparation and plantation establishment & One (1) year Maintenance & Protection covering Forty (40) hectares to be located in Brgy. Domonar, Ormoc City - P500,000.00

WHEREAS, as provided for in the MOAs, the DENR shall provide financial assistance to fund the execution of the said projects subject to the terms and conditions provided therein;

WHEREAS, the indicated projects object of the MOAs are likewise aligned to the List of 2016 Antipoverty Reduction Projects to be implemented in the city as embodied in SP Resolution No. 2014-231 of this Sanggunian;

WHEREAS, upon thorough review of the MOAs, this august Body finds that it is most beneficial to the city considering its general thrust of paving the attainment of environmental sustainability being one of our country's Millenium Development Goals (MDGs), and further, the same are found to be not contrary to law, existing contract and public morals, hence, most deserving of its full and prompt favorable support;

WHEREFORE, on motion of the Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by the Honorable SP Members Tomas R. Serafica, Mario M. Rodriguez, Ruben R. Capahi, Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga and John Eulalio Nepomuceno O. Aparis II; be it


ADOPTED, April 28, 2016.
