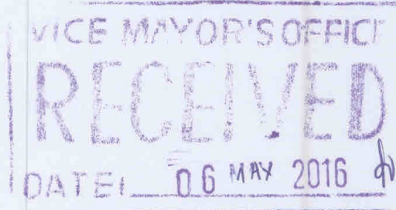

RESOLUTION NO. 2016-077

A RESOLUTION APPROVING THE APPLICATION FOR ACCREDITATION WITH THE LOCAL GOVERNMENT UNIT OF ORMOC, OF PARTNERS MULTI - PURPOSE COOPERATIVE (PMPC) IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO.009 DATED OCTOBER 16, 2014.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received the application of Partners Multi - Purpose Cooperative (PMPC), a Civil Society Organization (CSO) in Barangay Tongonan, Kananga Leyte, requesting for accreditation with the Local Government Unit of Ormoc;

WHEREAS, PMPC is an umbrella organization of various farmers and community associations belonging to the Sixteen (16) Primary Partner barangays (PPE's) of Energy Development Corporation (EDC) which were provided with different generating projects to enhance the financial condition of its members as part of EDC's Corporate Social Responsibility (CSR);

WHEREAS, it can be recalled that this Sanggunian has enacted Ordinance No. 009 dated October 16, 2014 entitled: "AN ORDINANCE REGULATING THE ACCREDITATION OF CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE CITY OF ORMOC" which governs the procedures for accreditation of legitimate organizations in the City of Ormoc;

WHEREAS, Section 2.1 of Ordinance No.009 provides among others that an organization may still be accredited after prescribe sixty (60) - day period within which application for accreditation shall be accepted, for purposes other than representation to local special bodies;

WHEREAS, this august Body, after thorough review of the aforementioned application, finds that the same is in order, and the purpose of the sought accreditation is for the aforementioned organization's continuous progress and development and to ensure that its member will be provided with sustainable livelihood projects by establishing a strong linkage with the LGU in order for the association to have a better access to future projects and programs of the government that are beneficial to its members;

WHEREAS, further, this august Body deems the application to be lawful being in accordance with the provisions of the Ordinance No, 009 hence, most deserving of favorable action by this Sanggunian;


